Shawn Carruthers called the meeting to order and led the *Pledge of Allegiance*.

Present: President Shawn Carruthers, Vice President John Schellenberger and Tim Kamer(virtual)

Also Present: Attorney Rick Fox, Assessor James Sinks, Auditor Jacqueline Wenning, Sheriff Frank Loop and Council member Denise Konkle.

Shawn Carruthers led a moment of silence for the residents that have been touched by COVID and the tornado victims in Kentucky

New Business:

The Commissioners presented ARP funding awards to 9 of the 28 Local Non-Profits impacted by the pandemic. The beneficiaries acknowledged were Big Brothers/Big Sisters, CASA, Clean Socks, Homeless Coalition of Southern Indiana, Hope Southern Indiana, St Elizabeth, Salvation Army, Rauch and YMCA.

1. Approval of Annual Bids

Motion to accept the bids excluding bids for guardrails. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

- 2. Mainstream Fiber-Zach Stephens
 - a. Progress Update

Zach Stephens gave an update on the Broadband expansion. He stated, as of now, they have only a few outlying sections of individual census block that still need to have their last laterals run to be connected by the end of 2021. They currently have between 160 and 180 active customers and have over 200 customers somewhere in the installation workflow. There is an extended installation time because it is new infrastructure. He stated the next step of expansion is running into complications for state level funding because of other providers requesting finding in the same areas.

Motion to pass with unanimous consent FCO 2021-29 Establishing MHMP Grant Fund 8112. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

Motion to approve with unanimous consent FCO 2021-30 System of Stormwater Management User Fees. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously

5. Building Authority – Aaron Combs

Aaron Combs gave a summary of 2021. He stated that in 2021 they accessed and quantified the condition of the City County Building and its systems. The need for renovations is unchallengeable. The preliminary design is complete but are only 15% into the projects. Step 1- The County Commissioners, along with the County Council, must confirm what the County can afford or are willing to spend on the transformation of the City County Building into a Judicial Center. They would like a decision by the end of January 2022.

Step 1a – Confirmation of target budget that will enable the architect to proceed with design development. This stage will take 4-6 months.

Step 2 – Commissioners authorized the Building Authority a request for information to measure private sector interest in developing the Grant Line Road Annex to a new county administrative center. The plans could also include Lifespring and the New Albany Floyd County Library, who is considering an annex similar to the one in Galena. This development could be known as the Floyd County Government and Community Center. The replies of the RFIs are due by the end of January.

Step 3 – Reducing the potential financing obligations for taxpayers takes three forms. The financial advisors have offered a preliminary assessment of four financing scenarios for the Judicial Center.

Step 4– Following the adoption of a budget and initiation of design development the architect and engineers will recommend a range of delivery options for review. This step will also include the initial development of a phasing plan that will address the continuation of government operations of judicial and administrative during the renovation project.

6. Director of Operations-Don Lopp

b. EMA – Radio Agreement

EMA Director, Kent Barrow, stated they would like to purchase new Motorola Radios for the Highway Department and Prosecutor's office. The current radios were purchased in 2006. The new radios will be supported by the state.

Motion to approve FCR-2021-17 the Board of Commissioners of Floyd County, Indiana for Certified Lessee Resolution for the lease with Motorola Solutions. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

Motion to approve the contract with Motorola for the purchase of 427 radios in the amount \$2,542,260.00. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

c. American Rescue Plan

FCO 2021-31 Amending ARP Plan

Shawn Carruthers excused himself because of conflict of interest.

Don Lopp stated the inclusion of New Albany Floyd County Educational Foundation for \$25,000.00 and an Additional \$20,000 for HYR due to clerical omissions in the original plan. Don Lopp stated the additions to the ARP Plan for areas with failing septic. He added East Knable for \$150,000.00, Tunnel Hill for \$200,000.00 and Whipperwill for \$550,000.00. This will bring the total for sanitary sewer to \$1,560,000.00 in allocation in the plan.

He asked to fund the local portion of the EMA radios through ARP funding and the Legacy Foundation Silo Funding through fund 9130.

Motion to approve the \$25,000.00 for the Educational Foundation, \$20,000.00 for HYR, funding for sewers for Buffalo Trace, Altawood, East Knable, Tunnel Hill and Whipperwill Sudivision and \$250,000.00 from ARPA Lost Revenue for EMA Radios in addition to Legacy and or the EDIT Fund. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

Motion to approve with unanimous consent FCO 2021-31 Floyd County Board of Commissioners Ordinance amending the American Rescue Plan Implementation Plan. Moved by John Schellenberger. Seconded by Tim Kamer. Motion passed unanimously.

Don Lopp stated he will be presenting a Broadband plan for second quarter 2022.
