## AN ORDINANCE VACATING PORTIONS OF CERTAIN PUBLIC STREETS

BE IT ORDAINED by the Board of Commissioners of the County of Floyd, Indiana, pursuant to I.C. 36-7-3-12, that:

SECTION 1. The following portion of certain public streets located in Plat 852 of the Floyd County, Indiana Records, located in Floyd County, Indiana, described as follows, to-wit:

Being a 0.2997 acre part of Ridgewood Drive a public street as shown on the plat of Ridgewood, Plat No. 852 of the Floyd County, Indiana record of plats and being a part of Section No. 19, Township 2, South, Range 5 East Georgetown Township, Floyd County, Indiana and being more fully described as follows, to-wit:

Beginning at the southwest corner of Lot Number 14 of said Plat No. 852 and on the northerly right-of-way line of Ridgewood Drive and running thence North 89 degrees 43' 11" East along the northerly right-of-way line of said Ridgewood Drive and along the southerly line of said Lot No. 14, a distance of 80.00 feet to a point; thence continuing along said northerly right-of-way line and along said southerly line of Lot No. 14 on a curve to the right, said curve having a central angle of 52 degrees 33' 33", a radius of 180 feet and a chord which bears South 64 degrees 00' 02" East, 159.39 feet to the southeast corner of said Lot No. 14; thence South 52 degrees 16' 44" West, 60 feet to a point on the southerly right-of-way line of said Ridgewood Drive and on the northerly line of Lot No. 15 of said Plat No. 852; thence along said southerly right-of-way line and along said northerly line of said Lot No. 15 on a curve to the left, said curve having a central angle of 52 degrees 33' 33", a radius of 120.00 feet and a chord which bears North 64 degrees 00' 02" West, 106.26 feet to a point; thence continuing along said southerly right-of-way line and along said northerly line of said Lot No. 15, South 89 degrees 43' 11" West, 80.00 feet to the northwest corner of said Lot No. 15 and on the west line of said Section No. 19; thence North Ø degrees 16' 49" West, along said west line, 60.00 feet to the place of beginning and containing 0.2997 of an acre of land.

## PETITION TO VACATE PART OF A PUBLIC WAY

TO: THE BOARD OF COMMISSIONERS OF FLOYD COUNTY, INDIANA

Robert A. Kelso files this petition as attorney for the petitioners, Elliott V. Phillips and Sue D. Phillips, who reside at No. 14 Ridgewood Drive, Floyds Knobs, Indiana. As provided by I.C. 36-7-3-12, the petitioners present to the Board of Commissioners of Floyd County, Indiana, that:

- 1. The circumstances of the case are as follows:
- a. On September 9, 1976, the petitioners, along with Linda Scharf, as owners of the real estate involved, created a subdivision known as Ridgewood, being Plat No. 852 in the records of the office of the Recorder of Floyd County, Indiana.
- b. That the petitioners built a home on Lot No. 14 and a barn on Lot No. 15 of said plat, and have resided there since 1976.
- c. That Ridgewood Drive, a sixty (60) foot right-of-way, was platted and dedicated to Floyd County, Indiana. Said roadway passes between Lot 14 and Lot 15 and serves no other land.
- d. That the petitioners now wish to vacate the part of this roadway that lies between their home and their barn.
- 2. A copy of Plat No. 852 is attached hereto showing the portion of the roadway to be vacated marked in red. The property proposed to be vacated is specifically described as follows:

Being a 0.2997 acre part of Ridgewood Drive a public street as shown on the plat of Ridgewood, Plat No. 852 of the Floyd County, Indiana record of plats and being a part of Section No. 19, Township 2, South, Range 5 East Georgetown Township, Floyd County, Indiana and being more fully described as follows, to-wit:

on the southerly right-of-way line of said Ridgewood Drive and on the northerly line of Lot No. 15 of said Plat No. 852; thence along said southerly right-of-way line and along said northerly line of said Lot No. 15 on a curve to the left, said curve having a central angle of 52 degrees 33' 33", a radius of 120.00 feet and a chord which bears North 64 degrees 00' 02" West, 106.26 feet to a point; thence continuing along said southerly right-of-way line and along said northerly line of said Lot No. 15, South 89 degrees 43' 11" West, 80.00 feet to the northwest corner of said Lot No. 15 and on the west line of said Section No. 19; thence North 0 degrees 16' 49" West, along said west line, 60.00 feet to the place of beginning and containing 0.2997 of an acre of land.

3. The petitioners own all of the land that abuts the property proposed to be vacated.
