

AN ORDINANCE ESTABLISHING COLLECTIVE BARGAINING  
FOR THE FLOYD COUNTY POLICE DEPARTMENT

WHEREAS, the Floyd County Commissioners, the Floyd County Council, the Sheriff of Floyd County, Indiana, and the Floyd County Sheriff's Merit Board desire to create and maintain an environment of cooperation and understanding with the merit employees of the Floyd County Police Department; and

WHEREAS, the Floyd County Commissioners, the Floyd County Council, the Sheriff of Floyd County, Indiana, and the Floyd County Sheriff's Merit Board wish to set forth in writing the salaries, wages, hours, and conditions of employment for the merit employees of the Floyd County Police Department; and

WHEREAS, the Floyd County Commissioners, the Floyd County Council, the Sheriff of Floyd County, Indiana, and the Floyd County Sheriff's Merit Board wish to be able to bargain in good faith without impasse arbitration but with the recognized bargaining representative and agent of said merit employees; and

WHEREAS, the interests of the citizens of Floyd County and the Floyd County Police Department will be well served by good faith bargaining with the merit deputies of the Floyd County Police Department.

NOW THEREFORE:

BE IT ORDAINED, that it is desired and deemed necessary to recognize the Fraternal Order of Police, Wyandotte Lodge 171, as the sole and exclusive bargaining agent for the purpose of establishing salaries, wages, hours, and conditions of employment for all merit county police officers without, however, impasse

arbitration. The Sheriff and the Chief Deputy, are excluded from this ordinance. The bargaining unit of the Fraternal Order of Police, Wyandotte Lodge 171, shall contain only members who are merit employees of the Floyd County Police Department.

BE IT FURTHER ORDAINED that this ordinance may be revoked by either the Floyd County Commissioners or the Floyd County Council for any reason at any regularly scheduled meeting of the Floyd County Commissioners or the Floyd County Council. However, the revoking body shall provide 30 days written notice of its intention to revoke this ordinance to the Floyd County Commissioners; or the Floyd County Council; the Sheriff of Floyd County; the Fraternal Order of Police, Wyandotte Lodge 171; and the Floyd County Sheriff's Merit Board.

BE IT FURTHER ORDAINED that this Ordinance shall be in full force and effect upon passage, and that two (2) copies of this Ordinance shall be forwarded to the Floyd County Auditor and to the Secretary of State of Indiana.
