AN ORDINANCE VACATING A PUBLIC PLACE OR WAY

WHEREAS, a petition for the vacation of a public place or way, pursuant to the provisions of IC 36-7-3-12, has been filed with the Board of Commissioners of the County of Floyd; and

WHEREAS, due notice of the filing of such petition was given as required by the provisions of IC 36-7-3-12 (c); and

WHEREAS, pursuant to notice, a public hearing was held on the petition on the 3rd day of April 2001, and no person spoke in opposition to the proposed vacation.

NOW THEREFORE:

BE IT ORDAINED, that the following described public place or way or portion thereof, to wit:


All of the 16 foot alley right-of-way, located between Lot Number 15 and 16, Plat Number 65 of the Floyd County, Indiana Records.

BE IT FURTHER ORDAINED, that the vacation of the public place or way described in this ordinance shall be subject to the rights of any public utility presently using all or any part of said public place of way.


