## FLOYD COUNTY ORDINANCE 2004- XXI

AN ORDINANCE APPROPRIATING EMERGENCY TELEPHONE SYSTEM FUNDS

WHEREAS, pursuant to the provisions of IC 36-8-16, et seq., the Floyd County Council has established a uniform enhanced emergency telephone system fee, which fees, upon receipt, are deposited by the Floyd County Auditor in the Floyd County Emergency Telephone System Fund; and

WHEREAS, the Floyd County Sheriff has petitioned the Board of Commissioners of the County of Floyd for authority to purchase equipment necessary to dispatch county fire departments, a service presently being provided by the Civil City of New Albany, Indiana; and

WHEREAS, the sheriff has further petitioned for funds necessary to hire additional dispatch personnel through the end of fiscal year 2004; and

WHEREAS, the Board of Commissioners of the County of Floyd has determined that the requested equipment and personnel constitute a necessary part of the emergency telephone system of Floyd County, Indiana; that the purchase and funding of same is authorized by the provisions of IC 36-8-16-14; and that the purchase of such equipment is consistent with the audit position of the state board of accounts; and

WHEREAS, the Board of Commissioners of the County of Floyd is presently desirous of approving the request of the Floyd County Sheriff, appropriating the necessary funds, and authorizing the sheriff to proceed with the purchase of equipment in accordance with IC 5-22-8 et seq.

## NOW THEREFORE:

BE IT ORDAINED, pursuant to the authority of IC 36-8-16-4, that a sum not to exceed \$50,000.00 be, and the same hereby is, appropriated from the Floyd County Emergency Telephone System Fund for the use by the Floyd County Sheriff in the purchase of new equipment which will be used by Floyd County to dispatch county volunteer fire departments.

BE IT FURTHER ORDAINED, that a sum not to exceed \$46,000.00 be, and the same hereby is appropriated so an to enable the

Floyd County Sheriff to hire and train necessary dispatch personnel through the end of fiscal year 2004.

BE IT FURTHER ORDAINED, that the Floyd County Sheriff be, and he hereby is, appointed as purchasing agent for the purpose of purchasing and acquiring the radio equipment for which this appropriation is made, all as permitted and allowed by the provisions of IC 5-22-8, et seq.

BE IT FURTHER ORDAINED, that all property and equipment purchased and installed pursuant to this appropriation and ordinance shall be and remain the property of Floyd County, Indiana, unless otherwise so ordered.
