

RESOLUTION OF THE BOARD OF COMMISSIONERS  
OF THE COUNTY OF FLOYD

FLOYD COUNTY RESOLUTION 1984-4

THIS INDENTURE WITNESSETH, that:

WHEREAS, at the meeting of the Board of Commissioners of the County of Floyd held on the 18th day of April, 1984, the Board reviewed and approved construction plans for the replacement of Bridge No. 33, same being located on Malinee Ott Road, and with the same crossing Georgetown Creek; and

WHEREAS, the discussion of the construction of this bridge necessarily included an acknowledgement by the members of the Board of Commissioners of the County of Floyd of the personal efforts of Walter Strahl, in his capacity as Floyd County Highway Engineer, in the development and finalization of these plans, in cooperation with AECON, Inc., Consulting Engineers, Nashville, Indiana; and

WHEREAS, the Board of Commissioners of the County of Floyd and the members thereof, individually, namely, Vincent Freiburger, Douglas Bierman and Edmund Knable, deemed it to be fitting and proper that a lasting memorial be established and dedicated for the purpose of properly and publicly acknowledging the professionalism, dedication and sincerity evidenced by Walter Strahl in the performance of his duties and responsibilities as Floyd County Highway Engineer prior to his death and passing on the 10th day of April, 1984; and

WHEREAS, upon motion duly made by Douglas Bierman, seconded by Edmund Knable, the following resolution was unanimously adopted:

BE IT RESOLVED, that Bridge No. 33 located on the Malinee Ott Road, Georgetown Township, Floyd County, Indiana, the same crossing Georgetown Creek be, and the same shall hereafter and henceforth be known and designated upon the official records of the Board of Commissioners of the County of Floyd as the Walter Strahl Memorial Bridge.

BE IT FURTHER RESOLVED, that AECON, Inc., Consulting Engineers, be and the Corporation is hereby directed and authorized to cause an amendment to the bridge plans and specifications so as to call for the erection upon the completed structure of a suitable plaque evidencing

the action of the Board designating this bridge as being the Walter Strahl Memorial Bridge.

BE IT FURTHER RESOLVED, that the Auditor of Floyd County, Indiana, is hereby directed to spread upon the records of the Board this Resolution as adopted.
