

FLOYD COUNTY RESOLUTION 2000- XII

A RESOLUTION ADDRESSING THE NEEDS OF THE RESIDENTS  
OF FLOYD COUNTY, INDIANA, TO BE SECURE FROM  
UNNECESSARY AIRCRAFT FLIGHTS OVER RESIDENTIAL AREAS

WHEREAS, as the result of the construction of parallel runways and other improvements at Louisville International Airport, the residents of Floyd County, Indiana, have witnessed an increase in air traffic over rural and urban residential areas; and

WHEREAS, attendant to such increase in traffic is an elevation of noise levels that is inconsistent with the character of the neighborhoods affected; and

WHEREAS, the governing body of Louisville International Airport has presently commissioned a "Part 150 Noise Compatibility Program", the implementation of which may adversely impact the residents of Floyd County, Indiana; and

WHEREAS, the Board of Commissioners of the County of Floyd is desirous of assuring that the governing body of Louisville International Airport give due and adequate consideration of the needs of the residents of Floyd County, Indiana, in the operation of its facility and the scheduling of flights.

NOW THEREFORE,

BE IT RESOLVED, that the governing body of Louisville International Airport, in the conduct and implementation of its "Part 150 Noise Compatibility Program", be and such body hereby is, requested and encouraged to adequately and fairly consider the needs of the residents of Floyd County, Indiana, namely, to be reasonably free from annoying disruptions and disturbances of the quietude of their residential neighborhoods which will necessarily result from increased air traffic and the frequency of flights over southern Indiana.

BE IT FURTHER RESOLVED, that the governing body of Louisville International Airport be, and it hereby is, requested and encouraged to recognize and acknowledge the dominant terrain

characteristics of rural Floyd County, Indiana; the impact of the increased topographical elevation of the "knobs" on relative aircraft altitudes and resultant noise levels; and, the uniqueness of the needs of the residents of Floyd County, Indiana, when compared to those of its sister communities.

BE IT FURTHER RESOLVED, that the governing board of the Louisville International Airport be, and it hereby is, requested and encouraged to permit final comments by the Board of Commissioners of the County of Floyd, or its designee, prior to the approval and implementation of any change or amendment to its Noise Compatibility Plan which would adversely affect the needs of the residents of Floyd County, Indiana.
