

FLOYD COUNTY RESOLUTION 2002-III
A RESOLUTION AUTHORIZING THE DISPOSAL OF CERTAIN
PERSONAL PROPERTY

WHEREAS, the Board of Commissioners of the County of Floyd has been advised by the Judge of the Floyd Superior Court that certain personal property formally used in his court room is surplus, has a value of less than \$1000.00, namely, \$175.00, and should be disposed of; and

WHEREAS, pursuant to the provisions of IC 5-22-22-4 personal property with a value of less than \$1000.00 may be disposed of by public or private sale or transfer without advertising, and, pursuant to IC 5-22-22-1(7) such property may be sold or transferred to certain not-for-profit Indiana Corporations without reference to Chapter 22 of the Indiana Code; and

WHEREAS, by ordinance duly adopted by this Board, the Judge of the Floyd Superior Court has been designated a purchasing agent for Floyd County pursuant to the provisions of IC 5-22-4-5 for certain purchases not to exceed \$25,000.00, and the Board of Commissioners of the County of Floyd are desirous by this resolution of designating the Judge of the Floyd Superior Court as the disposing agent for the personal property described herein.

NOW THEREFORE:

BE IT RESOLVED, that the Judge of the Floyd Superior Court be, and he hereby is, designated the disposal agent for the disposal of the following surplus property:

- (2) Television set (monitors);
- (1) Televisions stand.

BE IT FURTHER RESOLVED, that such property may be disposed of by private or public sale, without advertisement as permitted by the provisions of IC 5-22-22-6, for a sum not less than \$175.00, being the estimated reasonable value of the surplus property.

BE IT FURTHER RESOLVED, that the disposing agent is hereby authorized to sell and transfer the property described herein to an Indiana not-for-profit corporation organized for educational, literary, scientific, religious, or charitable purposes as described in IC 5-22-22-1(7), without reference to any requirement of Chapter 22 of the Indiana Code.

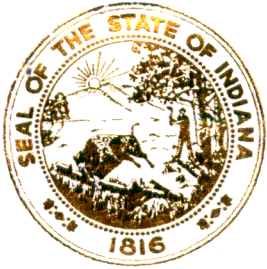
