RESOLUTION FCR-X

TO FLOYD COUNTY COMMISSIONERS, NEW ALBANY, INDIANA AUTHORIZING THE SUBMITTAL OF THE GRANT APPLICATION TO THE INDIANA DEPARTMENT OF COMMERCE AND ADDRESSING RELATED MATTERS

WHEREAS, the County Commissioners of Floyd County, Indiana recognizes the need to stimulate growth and to maintain a sound economy within its corporate limits; and,

WHEREAS, the Housing and Community Development Act of 1979, as amended, authorizes the Indiana Department of Commerce to provide grants to local units of government to meet the housing and community development needs of low and moderate income persons; and,

WHEREAS, the Floyd County Commissioners, have conducted or will conduct public hearings prior to the submission of an application to the Indiana Department of Commerce, said public hearings to assess the housing, public facilities and economic needs of its low and moderate income residents;

NOW THEREFORE, BE IT RESOLVED, by the County Commissioners of Floyd County, New Albany, Indiana, that:

- Floyd County will be lead applicant to submit an application on behalf of Guerin, Inc. for grant
 funding to address construction of a new senior citizens center to the service the residents of
 Floyd County, and to execute and administer a resultant grant including requisite general
 administration and project management, contracts and agreements pursuant to regulations of the
 Indiana Department of Commerce and the United States Department of Housing and Urban
 Development.

Floyd County Commissioners of Floyd County, Indiana hereby states that Guerin, Inc. will commit the requisite local funds in the amount of Eighty-six Thousand Seven Hundred Ninety-three Dollars (86,793.00), in the form of general funds as local match dollars; and, Floyd County Commissioners will commit the requisite local funds in the amount of Sixty-five Thousand Dollars (\$65,000.00), in the form of Riverboat proceeds, such commitments to be contingent upon receipt of CFF funding from the Indiana Department of Commerce.
