RESOLUTION OF THE NEW ALBANY-FLOYD COUNTY BUILDING AUTHORITY ("the BUILDING AUTHORITY") TO UNDERTAKE THE NECESSARY IMPROVEMENTS TO THE CITY-COUNTY BUILDING ("BUILDING")

WHEREAS, the Building Authority has always operated and maintained the City-County Building and other buildings previously owned by the Building Authority;

WHEREAS, the Building Authority is aware of the current condition of the Building and recognizes that the Building is in need of rehabilitation, improvements, and additions;

WHEREAS, the Building Authority will undertake and oversee the process of the necessary additions, improvements, and rehabilitation to the Building to make it into a Judicial Center for Floyd County, pursuant to Indiana Code § 5-23, Public-Private Agreements (the "BOT" statute); and

WHEREAS, the Building Authority will contract with a qualified provider pursuant to Indiana Code § 5-23, BOT statute, to make the necessary additions, improvements, and rehabilitation to the Building.

NOW, THEREFORE, BE IT RESOLVED BY THE NEW ALBANY-FLOYD COUNTY BUILDING AUTHORITY, THAT:

The Building Authority hereby recognizes and accepts the responsibility to undertake and oversee the necessary improvements, rehabilitation, and addition to the Building, pursuant to Indiana Code Title 5, Article 23, the BOT statute with all of its chapters, parts and subparts for purposes of utilizing Public-Private Agreements, and the Building Authority hereby approves

and resolves to issue an Request for Proposals to engage a private contractor with which to partner and accomplish the necessary additions, improvements, and rehabilitation to the Building as have heretofore been reviewed by the Board. The provisions adopted hereby shall be available for any project deemed appropriate by the Building Authority and the provisions adopted hereby shall continue without expiration.

This resolution shall be in full force and effect immediately upon its passage.
