**RESOLUTION OF THE BOARD OF COMMISSIONERS OF FLOYD  
COUNTY, INDIANA CONCERNING DISPOSAL OF PERSONAL  
PROPERTY**

WHEREAS JUDGE BROWN wrote On Oct 24, 2023, at 1:16 PM, Judge Brown <[jbrown@floydcounty.in.gov](mailto:jbrown@floydcounty.in.gov)> wrote:

Good afternoon gentlemen.

The Floyd Circuit Court currently has two Kardex Lektrievers in its possession. One is operational, and one is not. (image with ERR code)

I am unable, either by model number or serial number, to determine how old these units are, but I believe they have exceeded their life expectancy. As you can see from the attached images, they take up an inordinate amount of space, and, given that we are now primarily a paperless office, they lack the requisite functionality to justify the amount of space they are utilizing. I could better use that space for law clerks, research assistants as well as for my staff. I currently share my chambers with law clerks and assistants when they are here.

I have met with Nick Stone from Black Box Dumpsters LLC, who has provided what I infer to be a very reasonable quote (Dumpster costs plus \$140/hour labor for removal and haul off). He anticipates 4-7 hours of maximum labor, so a maximum costs range of approx.. \$1300. I can accommodate the total costs of removal within the Service Contracts line item of my budget. I have also checked with Mr. Edwards and have collected the requisite insurance information from the proposed vendor.

I believe the appropriate course of action is for me to request that this be added to the 11/6/23 agenda so that the Commissioners can determine whether this would be something that would go to auction, or if it would just need to be scrapped. We have offered this to the Clerk's office, but they do not have a need for it. I believe the Floyd County Library had previously shown interests, but the costs of disassembly, transport and reassembly was more than they were willing to pay. (This comes second hand to me) I am unaware of any county entity that would have need for this vertical filing carousel, and as such, I am requesting approval to have it removed so that I can better utilize the space.


