**Published Comment** Consult labels of any pesticides used. Ensure reheated foods reach 165F then are hot held at 135F or above. Discussed: Illness policy, vomit and diarrhea cleanup procedure, written notification of allergens, and proper thawing of Reduced Oxygen Packaged fish.
