

ORDINANCE NO. 2025-32

An ordinance of Harrison County, Indiana, amending the Harrison County Zoning Ordinance passed June 3, 1974.

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF HARRISON COUNTY, INDIANA, AS FOLLOWS, TO-WIT:

Upon the recommendation of the Harrison County Plan Commission the following sections are amended as follows:
