This withdrawal must be received by the official with whom the Declaration of Candidacy was filed not later than NOON, February 13, 2026. A candidate who has moved out of the election district, has been convicted of a felony or violating any other law that would prohibit the person from remaining a candidate, is on active duty in the U.S. Armed forces or subject to the Hatch Act or Little Hatch Act, a full-time employee of the Indiana Department of Homeland Security prohibited from participating in political activities under IC 10-14-3-26, and would violate any other law by remaining a candidate, or is a nonjudicial employee of a court who would violate the Indiana Code of Judicial Conduct by remaining a candidate may withdraw at any time.
