

HOWARD COUNTY COUNCIL REGULAR MEETING APRIL 26, 2005

The Howard County Council met Tuesday, April 26, 2005 at 7:00 p.m., in Room 338 of the Howard County Administration Center. Those present were Council President Richard Miller, Council Vice President James Papacek and Council Members Stanley Ortman, Leslie Ellison and Joseph Pencek. Also present were County Attorney Larry Murrell and Auditor Ann Wells.

The meeting was called to order by Sheriff Marshall Talbert and conducted by President Richard Miller.

The minutes of the March 22, 2005 Regular Meeting, having been previously reviewed, were considered and approved as presented on a motion made by Mr. Papacek, seconded by Mr. Pencek and carried.

IN THE MATTER OF COUNCIL OPENING COMMENTS:

Mr. Miller has noted the taxpayers' discouragement with the increase in taxes experienced by the city and a few of the city related townships. There was even an editorial that quoted a 17% county wide raise in taxes. Mr. Miller wanted to go on record saying that County General taxes went down from the year payable 2004 to year payable 2005.

ORDINANCE NO. 2005-HCC-17-ADDITIONAL APPROPRIATIONS

Voter's Registration Co-Director, Ms. Carol Shallenbarger took the opportunity to introduce Ms. Shirley McCoy, Co-Director, to the Howard County Council. Because of the training of new staff in the office and because of the upcoming conversion to the state-wide voter file, more part-time clerical monies are needed. The most time consuming portion of the conversion, is the state's request for a complete copy of all Voter Registration records. The third reason is because of annexation issues that have to be brought to the state.

The Council understands the need for the extra funds in the Part Time line but would like to approve a lesser amount at this time. If Voter's Registration still needs more funds before the end of the fiscal year, they can come back with a request at that time. A motion was made by Mr. Papacek and seconded by Mr. Ellison to approve an amount of \$10,000.00 additional monies to Line Item 01114.00.

The Council asked Mr. Harrison about the possibility of flexible hours with the existing employees. On a motion made by Mr. Papacek and seconded by Mr. Pencek, the Council agreed to table this request for one month, and directed Mr. Harrison to meet with the Board of Commissioners for additional ideas concerning flex-time for the Maintenance Department, to help alleviate some of the additional work load. The motion carried.

Mr. Cain also presented a request for \$243,184.00 in Bituminous.

Mr. Ortman made a motion to approve \$243,184.00 in Line Item 23754.00, Bituminous. This motion was seconded by Mr. Ellison and carried.

Mr. Cain wanted to remind the Council that several years ago the Cumulative Bridge Fund was decreased because of shortage of funds. While that fund has continued to operate during the decrease, he feels that in order for the Highway System to be maintained, an increase in funds would be necessary. He asks that the County Council remember his department when they are allowed by the state to increase the county budget. Mr. Miller thanked him for his comments.

The Judge of Superior Court III, Judge Douglas Tate, was in attendance, along with Senior Probation Officer, Gary Conwell, to request additional funds for part time work, as well as scanning equipment and related software. In 2004 additional part time funds were used to hire two interns to close old files and recoup funds; those funds were then forwarded to the state. The closed files were boxed and carried to the basement outside the Adult Probation offices. Those files are still used by Adult Probation but are in a place where they are being scattered and ransacked. The Judge would like to hire part time workers to scan those documents in the computer so they can be put in

another storage facility, while making the computerized files accessible to the Court, Clerk's Office and Adult Probation. The \$23,000.00 request is for the scanners and related software and licenses to facilitate the project. This scanner is a two sided scanner and will make the work go more quickly. The present scanner will be used as back up. They also plan on using this method to close out felony cases, and facilitate in Protective Order clean up. Mr. Conwell has a similar system available for his office, but this newer system would open access to the Clerk's office as well as Superior Court III. Future licenses can be expanded to include all the courts.

The Council was concerned that Judge Tate would work with the Board of Commissioners in the matter of storage for the hard copies. They approved the Additional Appropriation to Line Item 01115.00, Part Time Superior Court III in the amount of \$8,000.00 and Line Item 04721.00, Office Equipment in the amount of \$23,000.00 on a motion made by Mr. Ortman, seconded by Mr. Ellison and carried.

Kinsey Youth Center Director Jan Weaver resubmitted a request for a new vehicle which was tabled from the previous Council meeting (refer to page one of the March 22, 2005 Howard County Council Regular Meeting, *Cumulative Capital Fund Kinsey Youth Center Vehicle Purchase*). She explained, again, the age of the van and the amounts of repairs that are required. Also mentioned was the fact that they are receiving an increase in juveniles from other counties, increasing the need for dependable transportation.

The Council discussed the matter of a limited cash flow in the Cumulative Capital Fund and that there is a roofing project at the Administration Center and Howard Haven, that have already been approved and the bid process begun. After May 10th, taxes will have been collected and the bids will be in concerning the roofing project. On a motion made by Mr. Papacek, seconded by Mr. Pencek and carried, the Council will table this request until the May 17th Council meeting and exempt Mrs. Weaver from having to be present.

The Council approved the transfer request of \$1,966.00 from Line Item 01524.00 to Line Item 01523.00, \$1,200.00 from Line Item 03213.00 to Line Item 01523.00, and \$540.00 from Line Item 03590.00 to Line Item 01523.00 on a motion made by Mr. Papacek, seconded by Mr. Ortman and carried.

IN THE MATTER OF SALARY ORDINANCE NO. 2005-HCC-18 AMENDING SALARY ORDINANCE FOR 2005:

A motion was made by Mr. Papacek to approve the Salary Ordinance No. 2005-HCC-18 as read with two corrections. The first being in Howard County Voter Registration, change the amount in Line Item 01114.00 to \$10,000.00 and in Howard County Maintenance Department, change the amount in Line Item 01114.00 to -0-. The motion was seconded by Mr. Ellison and carried.

IN THE MATTER OF NEW BUSINESS:

Because the request was not received in time to be advertised, this matter will appear on the agenda for the May 17th meeting. However, a representative from the Kokomo Fire Department was asked to make an informal presentation and answer questions concerning the need and usage of an arson dog. Mr. Steve Stackhouse, Assistant Arson Investigator for the Kokomo Fire Department, was in attendance to speak of the usage of an arson dog. A presentation was made at the April 18th Commissioner meeting by Mr. Patrick O'Neill, Fire Marshal Investigator, and the Board of Commissioners approved a motion to donate \$2,000.00 from the Edit Funds. Mr. Stackhouse reported on funds already received, statistics regarding arson fires in Howard County and City of Kokomo, and who the dog would be made available to. The dog would be housed by the Kokomo Fire Department. A Chocolate Labrador Retriever has already been selected and is in training, as well two dog handlers.

IN THE MATTER OF RESOLUTION NO. 2005-HCC-08:

Howard County Commissioner Paul Raver was in attendance to present Resolution No. 2005-HCC-08, enlarging participation in the Public Employees' Retirement Fund. The Solid Waste Department has asked Howard County to sponsor three of their employees, director, assistant director and secretary, into PERF. Though sponsored by the County, the funds will be generated by the Solid Waste Department.

A motion was made by Mr. Papacek, seconded by Mr. Pencek and carried to approve Resolution No. 2005-HCC-08.

IN THE MATTER OF SHERIFF DEPARTMENT ISSUES:

Sheriff Marshall Talbert presented the following issues for Council information:

1. **Four of the new vehicles have been received.** Two of them are marked; two of them are unmarked. A quad cab pickup truck for Greg Hargrove in CID has been purchased. Sheriff Talbert reported that the Chrysler Corporation is manufacturing a Dodge Charger with either a V6 or V8 engine, the V6 being useful as an administrative car. He plans to dialogue with Chrysler about the possibility of the Sheriff's Department test driving the vehicles.
2. **Jail population at the present time is 243 inmates.** A request has been made to the Sheriff's Department, from Delaware County, to house twelve low risk inmates (no medical issues, and non-violent offenders). They would pay \$35.00 per day per inmate. The Council reminded the Sheriff that he has authority to accept or reject such requests.
3. **The Monthly Commissary Report for March, 2005** was presented to the Council.
4. **Accident Report and Firearm's Training Funds:** In a joint meeting with the Auditor, Ann Wells, and her financial staff, and Sheriff Talbert and members of his accounting staff, it was concluded that the Accident Report and Firearm's Training Funds do not need to be appropriated. It was suggested that the Sheriff's Department could run those funds in a similar fashion as the Commissary Fund, reporting to the Council on a monthly basis.

The Council stated that, as long as regular accounting procedures are followed and appropriate expenditures are observed, this procedure would be acceptable to them.

5. Both Sheriff Talbert and Attorney Murrell reported on the progress of the **Criminal Justice Coordinating Committee.** This committee is one of the principal suggestions of Consultant Wasson. In issuing invitations to the meeting, Mr. Murrell was met with good responses, and some judges voiced their approval of this Committee. Sheriff Talbert continued to inform the Council of possible scenarios of cooperation between the different arms of the Criminal Justice/Court System.

There being no further business to come before the Council, a motion was made by Mr. Papacek, seconded by Mr. Ellison and carried to adjourn. The meeting adjourned at 8:20 p.m.
