- II. Old Business
 - a. Review and approval of April 23, 2025 minutes.
 - b. ARC and Pretrial Updates Hope to have first participant in ARC in a week! Pretrail process questions have been answered from the State.
 - c. AllRise Conference and team report: Dustin Vice and Cathy Vawter highlighted where it was helpful to be around like-minded individuals and excellent information shared, including best practices. Full debrief will be scheduled so everyone can benefit from information learned for June 18 from 11:30-1pm which will also include JRAC meeting.
 - iv. Training highlighted the need for community development for more sober opportunities such as support groups and positive connection.



Jeremy Bays reports that he is developing a space for meetings and also sober fun. Jeremy is willing to lead a JRAC workgroup that focuses on these needed items. Gleeda Hadley, Dustin Vice and Cathy Vawter volunteered to serve on the committee.

III. New Business

- a. ARa update from Whitney Koelling, regarding Firefly Prevention Center. We are in talks with Firefly for \$15,000 grant to provide parent/child support program after school. Firely will return with response around July August 2025 timeline.
- b. OOR Owner Occupied Rehabilitation is a Resident-Focused Home Repair
 Program. Goals to increase access to safer and healthier homes, provide relief to families impacted by SUD and promote community and neighborhood safety.
 Types of repairs are: roofing, ADA accessibility, HVAC, water heater. This would assist 30-35 homeowners along the course of 18 months. 5 voting members of JRAC approved: Chris Doran (proxy Murielle Bright), Andy Judd, David Cheatham, Carin Hurt, Britt Burgmeier.
- c. Proposal for Opioid Settlement Funds from Gleeda Hadley. Funding for her position were previously obtained from 2023 Opioid Settlement Funds to fund position part-time and the other part-time funds were obtained from the LCC funds. Gleeda also shares that it was recently found that the Drug and Alcohol Task Force has lost non-profit status as of 2017. The goal is for the task force to become a non-profit again so that they can be their own fiscal agent. There is not



current funding for position in another area. The ask is for about \$89,500.00 which includes 30% which translates to 19,000.00 of fringe/benefits. This number will reduce if board task force approves funding, they would be estimated to provide 13,000.00 to the salary. JRAC to re-address on June 18th meeting.
