

RESOLUTION NO. 1993- 21

A RESOLUTION
OF THE COUNTY COUNCIL
OF MARTIN COUNTY, INDIANA,
AUTHORIZING PARTICIPATION IN
A MARTIN COUNTY HOUSING CONSORTIUM FOR
THE PURPOSE OF DISBURSEMENT AND ADMINISTRATION OF
HOME INVESTMENT FUND AND HOUSING DEVELOPMENT FUND GRANTS

WHEREAS, Martin County, IN, has, pursuant to Resolution No. 1993-11-12, of November 8, 1993, of the Board of Commissioners of Martin County, made application for Home Investment Fund and Housing Development Fund Grants with the Indiana Housing Finance Authority in order to fund a housing rehabilitation program in Loogootee, Martin County, IN, and

WHEREAS, the Town of Crane, the Town of Shoals, and the City of Loogootee have each made similar applications for Home Investment Fund and Housing Development Fund Grants, and

WHEREAS, the Board of Commissioners of Martin County, Indiana, has been awarded a Home Investment Fund Grant in the amount of \$431,579.00 and a Housing Development Fund Grant in the amount of \$68,121.00 from the Indiana Housing Finance Authority for the purpose of carrying out owner occupied housing rehabilitation projects in the Town of Crane, in the City of Loogootee, in the Town of Shoals, and in the unincorporated settlement area of Burns City in Martin County, and

WHEREAS, the total amount available for the all requested housing rehabilitation projects of any/or all of said governmental entities, as funded through the grants awarded to the Board of Commissioners of Martin County, is \$506,842.00, of which \$410,000.00 is for rehabilitation and \$75,263.00 is for program delivery and grant administration, and

WHEREAS, local banks have committed the local matching funds in the form of cash and in-kind services not to exceed \$6,842.00, in order to carry out the housing rehabilitation projects,

IT IS RESOLVED BY THE BOARD OF COMMISSIONERS OF MARTIN COUNTY, INDIANA:

1. The County shall join with the City of Loogootee, the Town of Crane, and the Town of Shoals, or any of said governmental units that may desire to participate, to form the Martin County Housing Consortium for the purpose of providing housing rehabilitation to eligible homeowners located within the corporate boundaries of said governmental units pursuant to said

grants received under the National Affordable Housing Act of 1990 and the HOME Program, administered in the State of Indiana by the Indiana Housing Finance Authority.

2. The President of the Board of Commissioners is designated as the County's representative to the Martin County Housing Consortium and shall have authority, pursuant to I.C. 36-1-7, to enter into an Agreement Of Participation In The Martin County Housing Consortium for the purposes set out above and to act on behalf of the City in matters coming before the Martin County Housing Consortium, which Agreement is approved.

3. The Southern Indiana Development Commission shall continue to be designated to act as Subrecipient for program delivery and grant administration to carry out the housing rehabilitation program pursuant to the prior Subrecipient Agreement with the County.
