EMPLOYEES WHO OPT OUT OF HEALTH INSURANCE WILL RECEIVE AN ADDITIONAL \$4,000 DISPERSED EVENLY THROUGHOUT THE 26 PAYS. AN EMPLOYEE WHO BEGINS EMPLOYMENT DURING THE YEAR WILL RECEIVE A PRO-RATED PORTION. EMPLOYEES WHO CHOOSE HEALTH INSURANCE ARE RESPONSIBLE FOR 10% OF THE HEALTH INSURANCE PREMIUM.

PART TIME EMPLOYEES WITHOUT A DESIGNATED WAGE LISTED, WILL RECEIVE BETWEEN \$7.25/HR-\$13.000/HR. THE DEPARTMENT HEAD WILL DETERMINE THE HOURLY WAGE.

EXCEPTIONS: CIRCUIT COURT/PROBATION EMPLOYEES CAN RECEIVE UP TO \$12.50/HR  
ANIMAL CONTROL OFFICER CAN RECEIVE UP TO \$12.50/HR  
HEALTH DEPARTMENT PUBLIC HEALTH COORDINATOR CAN RECEIVE UP TO \$21.50 /HR  
HIGHWAY DEPARTMENT PT EMPLOYEES CAN RECEIVE UP TO \$12.5/HR.  
THE DEPARTMENT HEAD WILL DETERMINE THE HOURLY WAGE.

SECURITY CENTER FULL TIME STAFF CAN BE ELIGIBLE FOR A NEW HIRE BONUS UP TO \$1,000 BASED ON THE GUIDELINES IN THE HIRE BONUS POLICY .  
SECURITY CENTER FULL TIME STAFF CAN BE ELIGIBLE FOR A REFERRAL BONUS OF UP TO \$500 BASED ON THE GUIDELINES IN THE <sup>Referral</sup> HIRE BONUS POLICY .  
SECURITY CENTER FULL TIME STAFF CAN BE ELIGIBLE FOR A RETENTION BONUS BASED ON THE GUIDELINES IN THE <sup>Retention</sup> HIRE BONUS POLICY .
