

**RESOLUTION ESTABLISHING MARTIN COUNTY
EMERGENCY MANAGEMENT ADVISORY COUNCIL
AND ESTABLISHMENT OF RESPONSIBILITIES**

WHEREAS, Indiana Code §10-14-3-17 directs that a county shall establish and maintain a county emergency management advisory council; and

WHEREAS, Indiana Code §10-14-3-17 establishes the membership of the county emergency management advisory council; and

WHEREAS, Indiana Code §10-14-3-17 further provides that the responsibilities of the county emergency management advisory council shall include

1. Exercise general supervision and control over the emergency management and disaster program of the county.
2. Select or cause to be selected, with the approval of the county executive, a county emergency management and disaster director who shall be responsible for the organization, administration, and operation of the emergency management program in the county;
3. Under the provisions of Indiana Code §10-14-3-17, to supervise the provision of:
 - (a) Disaster prevention;
 - (b) Preparedness;
 - (c) Response; or
 - (d) Recovery services for the county;
4. Supervision of the preparation of and maintain a revision of a local disaster emergency plan for the county.


NOW THEREFORE, BE IT RESOLVED, by the Board of Commissioners of Martin County Indiana, as follows:

1. That Martin County Board of Commissioners recognizes and adopts the requirements for emergency management organization as established by Indiana Code §10-14-3-17.
2. That in compliance with Indiana Code §10-14-3-17(c), the Board of Commissioners does establish the Martin County Emergency Management Advisory Council.
3. That the Martin County Emergency Management Advisory Council shall have jurisdiction over and serve the entirety of Martin County.
4. That pursuant to the directions of Indiana Code §10-14-3-17, the Martin County Emergency Management Advisory Council shall consist of the following individuals or their designees:
 - (a) The President of the Martin County Board of Commissioners;
 - (b) The President of the Martin County Council;
 - (c) The Mayor of the City of Loogootee;
 - (d) An individual representing the Loogootee City Council, the Shoals Town Council, and the Crane Town Council;
 - (e) And representatives of private and public agencies or organizations that can assist emergency management considered appropriate by the Martin County Emergency Management Advisory Council.
5. That the Martin County Emergency Management Advisory Council shall exercise general supervision and control over the emergency management and disaster program of Martin County.
6. That the Martin County Emergency Management Advisory Council shall select or cause to be selected, with the approval of the county executive, a county emergency management and disaster director who shall be responsible for the organization, administration, and operation of the emergency management program in the county and shall be responsible to the Chairman of the Martin County Emergency Management Advisory Council.
5. That the Martin County Emergency Management Advisory Council shall supervise the provision of:
 - (e) Disaster prevention;
 - (f) Preparedness;
 - (g) Response; or

- (h) Recovery services for Martin County.
6. That the Martin County Emergency Management Advisory Council shall supervise the preparation of a local disaster emergency plan for Martin County and to assure appropriate revision of said plan.
 7. That Martin County shall continue to follow the requirements as established by Indiana Code §10-14-3-17 as it presently states or shall be amended.




