- Tax Bills are scheduled to be mailed April 1<sup>st</sup>.
- Spring tax bills are due Monday, May 11<sup>th</sup>. A change to this due date has to come from an action of the state legislative bodies.

2. PAY ONLINE BY E-CHECK (\$1.50), CREDIT OR DEBIT CARD (\$3.95 or 2.45%) OR BY PHONE USING THE SAME METHODS.

3. DROP BOX LOCATED OUTSIDE THE COURTHOUSE NEAR THE NORTH DOORS. (IT WILL BE installed in the coming weeks.)
4. PAY AT ONE OF 3 LOCAL BANK BRANCHES COLLECTING ON OUR BEHALF. FIRST FINANCIAL BANK AND FARMERS AND MECHANICS FEDERAL SAVINGS AND LOAN(1).
