ACCEPTANCE OF TERMS FOR USE OF THE KARST DOG PARK

I agree to abide by all the rules and health requirements established for the Dog Park at Monroe County's Karst Farm Park as set forth in the Dog Park registration form and assume responsibility and liability for loss, damage, or injury of any kind sustained by any person or canine caused by my dog(s) while inside the Dog Park. I recognize that because of the nature of canine activities that an injury may be sustained to my dog(s), my guest(s) and me, and understand that neither persons nor dogs are covered by County provided medical insurance. I understand that any dog declared Potentially Dangerous or Vicious by Monroe County's or Bloomington's Animal Care & Control Commission, or similar declaration by any other governmental entity, is prohibited from using the Dog Park.

I now release the County of Monroe, Indiana, the Monroe County Parks & Recreation Department, its employees, volunteers, sponsors, officers, and agents for any personal injuries or damages to my personal property caused by or having resulted from my use, or that of my dog(s), of the Dog Park. I understand that this release applies to both present and future injuries and damages, and that it binds my heirs, executors and administrators.

FEE & REGISTRATION

- Household Annual Fee: \$50, one membership includes all dogs living at the same residence.
- All dogs must be registered as a dog park member.
- Produce documentation of vaccinations and spay/neuter.
- Review, agree to, and sign the Acceptance of Terms.
- Once registered, a Karst Dog Park dog tag and a key fob are issued for access to the front gate.

HEALTH REQUIREMENTS

- Dogs must be spayed/neutered and at least 4 months of age.
- Rabies, Bordetella, DAPP (distemper, adenovirus, paravirus & parainfluenza) vaccinations are required.
- Strongly recommended, but not required: Negative stool sample for parasites and Leptospirosis vaccination.

SAFE & SECURE CLEAN & CONTROLLED

- A Karst Dog Park key fob is required for electronic entry through the front gate; when membership expires, the electronic key fob will no longer work.
- Safety features include a 6' exterior & 5' interior fence and double-gated entries & exits.
- Karst Dog Park is managed by Monroe County Parks & Recreation.
- For the health & well being of your dog, a routine grounds maintenance schedule is followed.
- "Scoop the Poop" stations are available with baggies & scoops for easy clean-up.

DOG PARK AMENITIES

- The two-acre park is divided into two enclosed areas.
- On each visit you may use either enclosure. Please use good judgement.
- 1.5 acre enclosure: active/herding/stronger dogs.
- .5 acre enclosure: less active/smaller/older/shy dogs.
- Free guest dog privileges, ask for details.
- Drinking water for you & your dog.
- Picnic tables & benches
- Trees & landscaping
- 1/6 mile walking trail
- Shade shelters
- Paw sprayer

RULES FOR DOGS & OWNERS

1. Dog owners are solely responsible for their pets' actions, behavior, & security.
2. All patrons use the Dog Park entirely at their own risk and that of their dog(s).
3. Infants & children under twelve (12) years of age are never allowed in the Dog Park.
4. Youth 12-15 years of age must always be supervised by an adult.
5. All dogs must display on their collar a Karst Dog Park tag, rabies tag, & ID tag.
6. Do not bring your dog to the Dog Park if it is sick, contagious, or injured.
7. One person is required to be present for every two dogs.
8. Unleash your dog inside the Dog Park and carry the leash with you at all times.
9. Handlers must scoop the poop and fill any holes dug by their dog.
10. Handlers must have their dog in sight at all times.
11. If your dog becomes unruly, plays rough, or becomes aggressive, leash him and leave immediately. Some days, it may be a poor mix of dogs. Leave the Dog Park and return later.
12. Dogs known to exhibit vicious, aggressive, or dangerous behavior are not permitted.
13. No smoking, eating, or glass containers in the Dog Park.
14. Do not bring food dishes, dog food, favorite toys, or chews/rawhides. Small training treats are admissible as long as other dogs are not provoked.
15. It is permissible to bring a fetch toy, such as a tennis ball, as long as it does not provoke other dogs.
16. No animals other than dogs shall be permitted in the Dog Park.
17. Spiked/pronged/pinch/shock collars are not allowed.
18. You must not grant entry to unauthorized users of the Dog Park or privileges will be revoked.
