# MINUTES OF A REGULAR SESSION OF THE BOARD OF COMMISSIONERS HELD December 13, 2021

Comes now the hour of 8:30am. on the 13<sup>th</sup> day of December, 2021 in the Commissioners Room in the Noble County Courthouse, Albion, Indiana, being the time, date and place set for a regular session of the Board of Commissioners of Noble County, Indiana.

Gary Leatherman, Commissioner President, called the meeting to order at approximately 8:30am.

#### MINUTES

Minutes of the previous meeting were read and approved as written with a motion from Dave Dolezal and a second from Anita Hess. Motion carried 3-0.

## **CLAIMS**

Claims dated 12/13/2021 were reviewed and approved with a motion from Dave Dolezal. The 17-page report totaled \$405,586.22. Anita Hess seconded the motion. Motion carried 3-0.

# **PAYROLL**

Payroll dated 12/02/2021 was a 4-page report totaling \$425,965.19 and was approved with a motion from Dave Dolezal and a second from Anita Hess. Motion carried 3-0.

Payroll dated 12/16/2021 was also available for review. Dave Dolezal moved to approve the 4-page reported that totaled \$452,367.04. Anita Hess seconded and the motion carries 3-0

## OPIOIDS SETTLEMENT

Notification had been received concerning settlement participation in an opioid settlement suit. Dennis Graft, Noble County Attorney, has completed the participation form and is asking the commissioners to sign. Dave Dolezal moved to sign the form. Anita Hess seconded and motion carried 3-0.

# **ORDINANCE**

A council redistricting ordinance was presented to the commissioners for signature. This redistricting is needed for deviation compliance following the recent census. District one will consist of precinct Perry 3, 4,5 and 6; Sparta 2; York 8; and Washington 1.

District two will consist of Wayne 15; Orange 12, 13 and 14; Elkhart 7; Albion 28; and Jefferson 11

District three will be comprised of Allen 24, 25 and 26; Swan 27, Green 10 and Noble 9, 29.

And District four will consume Wayne 16, 17, 18, 19, 20, 21 and 22; and Allen 23.

Motion to approve the ordinance as presented came from Dave Dolezal and was seconded by Anita Hess. Motion carried 3-0.

#### **HIGHWAY**

Richard Rogers, Highway Superintendent, and Anna Vice, Bookkeeper, are present in the absence of Zack Smith, Highway Engineer.

- The Annual bids were received and opened at this meeting. After all were opened and announced Dave Dolezal made a motion to accept the bids for future review. Anita Hess seconded and the motion carried 3-0.
- Richard has a driveway variance for approval for Rodney Schoon on 415 N. This is simply because it is located near another drive on that road. Motion to approve came from Dave Dolezal and was seconded by Anita Hess. Motion carried 3-0.
- Another driveway variance for Miller on 600 W was also considered. This too is located near another driveway but has good sight and drainage reports. Dave Dolezal moved to approve the variance. Anita Hess seconded and motion carried 3-0.
- Richard reported some clean up after the Friday night/Saturday Morning storms.

#### **ENGINEERING**

- Community Crossing Project HMO -02 this is out for bid.
- 400 N LPA Voucher the voucher for \$1934.30 for engineering was approved with a motion from Dave Dolezal. Anita Hess seconded the motion. Motion carried 3-0.
- 400 N there is another LPA for this project for right of way. This is in the amount of \$6,303.94 and is approved with a motion from Dave Dolezal. Anita Hess seconded and motion carries 3-0.
- Concerning the condemnation for a property on 400 N that will not respond to notices,
   Dennis reported that the hearing is set for December 16, 2021 in Circuit Court.
- Bridge 69-Richard has an LPA Voucher for engineering in the amount of \$1,323.36. Dave Dolezal moved to approve this voucher and it was seconded by Anita Hess. Motion carried 3-0.
- Old State Road 3 Notice to proceed has been issued.
- Little Long & Round Lake Richard has a cover sheet for this project to sign. Motion to sign came from Dave Dolezal. Anita Hess seconded 3-0.
- Crash at 900 W and 200 N Richard reported that the department has put more spinners at the location. The department has also "stop ahead" signs to warn motorists. The department still does not have the crash report to indicate the cause of the crash which is thought to be due to excessive speed.

There is money available in this fund as well. Dave Dolezal moved to allow the painting to be done over Christmas break and to split the cost between the above-mentioned funds. Anita Hess seconded and the motion carried 3-0.

Anne is also asking permission to by a new laptop out of the Public Health Vaccine fund. current computer is bulky and does not have the capability of doing some of the things needed at the clinic site project. Dave Dolezal moved to approve the purchase out of her funding. Hess seconded and motion carried 3-0.

Anne updated the commissioners on the COVID situation. Unfortunately, we are still red and at A lot of this is due to non-vaccinated people and for whatever reasons a high positivity level. More clinics opportunities are going to be available to people for people do not get vaccinated. both the vaccines and boosters.

## LANDFILL

Derek Faulk and Jeremy Kinman, were present from Wilcox Environmental Engineering, to discuss landfill issues. Derek reported that he will be retiring on December 31, 2021 and Jeremy will be our new representative.

Derek reported that a "baler" had been found in #6, so they will be attempting to remove that from the well and so an anticipated repair to the well will no longer be needed.

The last thing that Derek had was a proposal for 2022 from Wilcox. The proposal was reviewed and signed with a motion from Dave Dolezal. Anita Hess seconded and the motion carried 3-0.

## **EXTENSION CONTRACT**

The contract with the Extension Office was also signed with a motion from Anita Hess. Dave Dolezal seconded and the motion carried 3-0.
