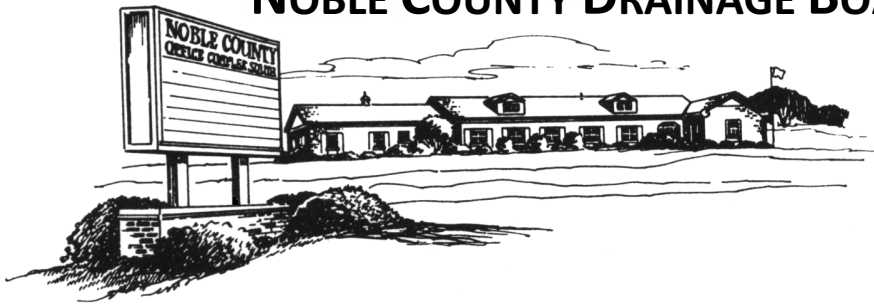

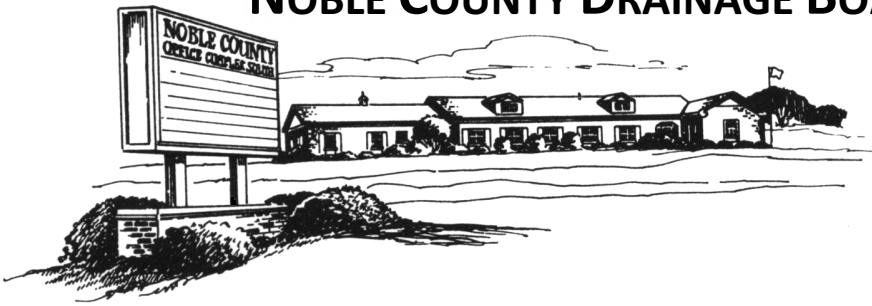
PETITION TO CONVERT A PRIVATE DRAIN / MUTUAL DRAIN TO A REGULATED DRAIN

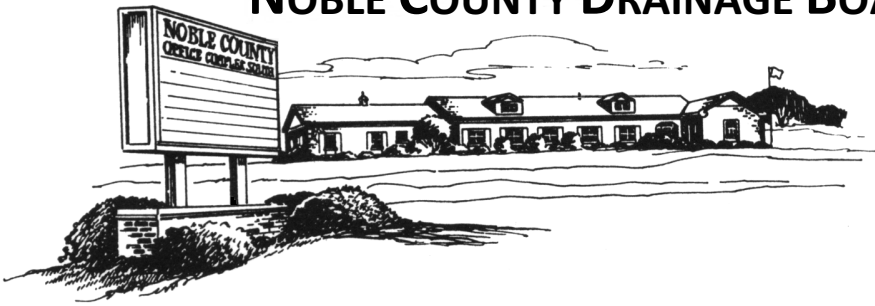
