BOARD OF COMMISSIONERS November 16th, 2015

- I. CALL TO ORDER: The Parke County Board of Commissioners convened in a regular meeting at 4:00 p.m. on Monday, November 16th, 2015, having adjourned from a regular meeting on Monday, November 2nd, 2015.
- II. ROLL CALL: Members present were Commissioners Jim Meece, President; Dan R. Collom, First Vice President; Bruce Hartman, Second Vice President; Pam Adams, Auditor; Janie Hardman, 1st Deputy Auditor; and County Attorney John Asbury. Also present were Derek Goodman, Karla Losin, Walt Wilson, J.B. Butler, Pam Sanders, Cassie Wittenmyer, Jeff Horsley, Abel Contreras, Lois Jones, Paul Jones, Justin Cole, Larry Bemis, Brent Holl, Kristina Alexander, Cierra Earley, George Smith, and Randy Norman.
- **III. MINUTES:** Minutes for the regular meeting on Monday, November 2nd, 2015 were approved on a motion made by Bruce Hartman and seconded by Dan Collom. The motion carried unanimously.
- IV. PAYROLL: County payroll in the amount of \$148,087.43 was approved for release on Monday, November 16th, 2015 on a motion made by Dan Collom. Bruce Hartman seconded the motion and it carried unanimously. Dan Collom made a motion acknowledging receipt of the Payroll Claims Accounts Payable Report in the amount of \$124,713.67. Bruce Hartman seconded the motion and it carried unanimously. The Board acknowledged receipt of the October Monthly Financial Report.

V. NEW BUSINESS:

- Bruce Hartman made a motion to approve a hand-typed check in the amount of \$10,000.00 payable to Parke County Incorporated and in the amount of \$150.00 payable to International Emergency Medical Dispatch Academy. Bruce Hartman seconded the motion and it carried unanimously.
- Bruce Hartman made a motion to adopt **Resolution 2015-12** confirming Parke County's participation in the Wabash River Heritage Corridor Commission and to retain Penny Cox as Parke County's appointment and Phil Cox as the alternate appointment effective for a two-year term beginning January 1st, 2016 and expiring December 31st, 2017. Dan Collom seconded the motion and it carried unanimously.
- The Wabash River Heritage Corridor Commission Meeting Agenda and Minutes were presented for review.
- The Board reviewed the 2016 Temporary Food Permit Application and the Fee Schedule for the Parke County Health Department.
- Bruce Hartman made a motion to enter into the agreement between PayGOV.US, LLC and the Parke County Health Department to provide a payment processing system for credit or debit cards to be used for processing obligations on a 24/7 basis. Dan Collom seconded the motion and it carried unanimously.
- Dan Collom made a motion to approve the change order in the amount of \$11,073.81 for Gibson Teldata. The Courthouse will have a total of seven analog lines and the Sheriff's Department will have five analog lines. The Highway Department will get a bigger UPS in case of power outage. Six 5340 IP telephones will be replaced with six 5320 IP telephone lines. Ten 5320 IP telephones and licensing will be added. The wall mount racks at the Extension, Courthouse and Sheriff's Department will be removed from the order. Two additional cable runs at the Highway Department will be included. A patch panel will be included for the Ambulance Building and Prosecutor's Office. This change order will increase the monthly bill by \$200.00. Bruce Hartman seconded the motion and it passed unanimously.
- Youth in Government Day is on December 3rd, 2015. Lunch will be at the St. Joseph's Catholic Church Holy Family Hall.
- The Board reviewed Progress Report #010 and Field Report #016 from ARSEE Engineers, Inc. regarding the progression of work on the Courthouse clock tower.
- The Board agreed to be a consulting party for the Rehabilitation of Bridge No 163-83-05325A Des. No. 1298390 SR 163 over the Wabash River.
- The Board determined to leave the flag as is and not lower it to half-staff per Governor's request for the recent tragedy in Paris.

VI. OLD BUSINESS:

• Jim Meece signed the Medical renewal quote with Anthem. The medical premiums for 2016 will remain the same as 2015.

VII. DEPARTMENTAL REPORTS:

Parke County Planning Commission, Cassie Wittenmyer:

- Bruce Hartman made a motion to approve the certification for the zoning map change for the construction of a Dollar General Store in Bellmore. Dan Collom seconded the motion and it carried.
- Bruce Hartman made a motion to adopt Same Day, Same Meeting, Ordinance 2015-09. Dan Collom seconded the motion and it carried unanimously. Bruce Hartman made a motion to adopt Ordinance 2015-09 which rezones a part of Union Township 15N, Section 7, Range 6 West, containing 2.85 acres, more or less, from AP – Ag Productive to CLB-Commercial Local Business. Dan Collom seconded and the motion and it carried unanimously.

Parke County Sheriff, Justin Cole:

- The Jail count for today was eighty; thirty-nine County, three department of correction, thirtytwo out-of-county and six away.
- Dan Collom made a motion to enter into the agreement between PayGOV.US, LLC and the Parke County Sheriff's Office to provide a payment processing system for credit or debit cards to be used for processing bond payments. The service fee for a bail payment is seven percent. The County will receive fifteen percent of the service fee. Dan Collom seconded the motion and it carried unanimously.
- Dan Collom made a motion allowing Cole to apply for a grant to purchase eight automated external defibrillators (AED). Bruce Hartman seconded the motion and it carried unanimously.
