

COUNTY COUNCIL

January 9th, 2025

- I. CALL TO ORDER:** The Parke County Council convened in a regular meeting on Thursday, January 9th, 2025 to consider additional requests in excess of the budget allowed for 2024-2025, and to conduct such other business as may be properly brought before the Council.
- II. ROLL CALL:** Council members present were, Roy Wrightsman, Vice President; Jack B. Butler; James E. Howard; Rick Patton; Thomas Rohr; Matthew Helderman; Mary Alice Gregg; and Susan Kramer, Auditor. Also present were Jason Frazier, Chris Newcomb, Natalie Cole, Stacie Amerman, Mandy Adams-Washburn and Chester Crague
- III. READING OF THE MINUTES:** Minutes for the Council Meeting held on December 12th, 2024 and the Council Meeting held on December 30th, 2024 were presented. Rick Patton made a motion to approve the December 12th, 2024 meeting minutes as presented and the December 30th, 2024 meeting minutes as presented. Jim Howard seconded the motion and it carried unanimously.
- IV. ADDITIONAL APPROPRIATION REQUESTS:** No additional appropriations requested.
- V. JURY PAY:** The Auditor presented the Parke County Clerk's Certification of jury fees collected for December 2024, and requested \$254.23 be transferred into the Jury Pay Fund, pursuant to IC 33-19-8-8. Rick Patton made the motion to direct the Auditor to transfer the jury fees collected in the amount of \$254.23 from the County Users Fund to the Jury Fee Fund. VII. COMMITTEE REPORTS:

Redevelopment Commission (RDC): Did not meet

Courthouse Security Committee: Did not meet.

Planning and Zoning Board:

Planning and Zoning Administrator continuing to send out notice of violations to landowners.

Disgruntled landowner that continued to place false statements regarding the Administrator on Parke County Chatter was fined \$5,000 by the court for failure to appear for his notice of violations.

VIII. DEPARTMENT HEAD REPORTS:

- **Susan Kramer, Auditor:**

- The Auditor's Cash Flow Statement was submitted for review by the Council Members.

- **Jim Meece, Commissioner:**

- Recent weather condition led to a few issues with the Highway Department but over all everything was handled efficiently. Bailey Chapel Hill Road was closed temporarily for the safety of Parke County residents.
- Courthouse Flag was lowered to half-staff in honor of Former President Jimmy Carter.
- Executive Session scheduled for Thursday, January 16th, 2025 to review resumes/applications received for the Highway Superintendent position.
- Commissioners are establishing a Solar Committee to discuss Parke County's current moratorium on renewable energy. The ordinance states that it can only be used for residential needs, any excess would need to be stored in battery back-ups and can not be sold back to the grid. Selling the excess back to the grid would deem it a commercial venture which is banned by the moratorium. The following is a list of the current Solar Committee members;

Jim will also ask fellow Commissioners Bob Davis, Sullivan County and John Frye, Montgomery County to attend meetings to get their insight on benefits and or issues that their counties have had with renewable energy, solar being the main focus.

- **Natalie Cole, Health Department Nurse:**

- Presented a request for grant application. Natalie is seeking a Parke County Community Foundation grant to purchase sleep sacks for infants the were previously provided by the State of Indiana to protect infants from suffocation. Natalie reported that there is a need to provide a safe sleeping environment for infants, last year there were roughly 200 births in Parke County. The distribution of the sleep sacks would be free to those in need, if purchased in bulk the Health Department would be able to get 100 sleep sacks with shipping for \$1200.00. Tom Rohr made a motion to approve Natalie Cole to seek a Parke County Community Foundation grant for infant sleep sacks. Matt Helderman seconded the motion and it carried unanimously.

- **Chris Newcomb, Park and Recreation Director:**

- Chris Newcomb would like to seek a Community Impact Grant through the Department of Natural Resources to replace playground equipment at the Rockville Lake Park. Deadline for the grant application is February 28th, 2025, Chris will obtain the necessary paperwork from the Auditor's office. Chris is seeking \$5,000 in grant funds for this project. Tom Rohr made a motion to approve Chris Newcomb to seek a Department of Natural Resources grant to replace play ground equipment. Mary Alice Gregg seconded the motion and it carried unanimously.

- **Jason Frazier, Sheriff:**
 - Jason Frazier presented the Council Members with his 2025 Parke County Sheriff's Compensation Contract for approval. Thomas Rohr made the motion to approve the Parke County Sheriff's Compensation Contract for 2025. Jack B Butler seconded the motion and it carried unanimously. The Compensation Contract was approved by the Board of Commissioners on January 8th, 2025.
- **Stacie Amerman, Hamilton Center:**
 - No Updates

IX. NEW BUSINESS:

- President Roy Wrightsman would like to establish a public comment policy stating that a time limit of 3 minutes will be imposed and the member of the public must be signed in on the meeting roster located in the back of the room. Jack B Butler made a motion to approve the public comment policy. Matt Helderman seconded the motion and it carried unanimously.
- Due to a miscommunication regarding the Health First Initiative funding amount required by the State, health insurance for the Health Department will be maintained in the general fund.
- President Roy Wrightsman introduced Robert Clutter, attorney for the Parke County Council. Engagement letter was presented for 2025 agreeing to perform requested services including bond work at his normal \$360.00 per hour billing rate with no retainer amount being required. Tom Rohr made a motion to approve the letter of engagement with Robert Clutter. Jack B Butler seconded the motion and it carried unanimously.
- President Roy Wrightsman reported on the Innkeepers Tax increase and issues when the original bill was passed it did not include the provision that the increase was to go towards public safety, statutory guidelines state the increase is to be used for tourism unless otherwise stated. Senator Deery is trying to get the issue rectified but until that passes the innkeepers tax collection revenues deemed for the volunteer fire departments will be held. Roy will be writing a letter to the fire departments explaining the situation and will have the Auditor send on his behalf. Roy presented the Parke County First Responder Runs data that he had received from the EMA Director, Chris O'Brien the information was generated from the CAD System.

Total runs is all runs by all departments in a first responder role. Does not include fire related runs.

State Property runs include runs to state-owned properties (parks, buildings, conservation areas) only.

Total adjusted is the sum of total runs and state property runs, giving double weight to state property runs.



X. OLD BUSINESS:


- 2025 Certified Budget Order was received from the DLGF on January 6th, 2025.
