COUNTY COUNCIL November 14th, 2024

- I. CALL TO ORDER: The Parke County Council convened in a regular meeting on Thursday, November 14th, 2024 to consider additional requests in excess of the budget allowed for 2024, and to conduct such other business as may be properly brought before the Council.
