COUNTY COUNCIL December 12th, 2024

- I. CALL TO ORDER: The Parke County Council convened in a regular meeting on Thursday, December 12th, 2024 to consider additional requests in excess of the budget allowed for 2024, and to conduct such other business as may be properly brought before the Council.
- II. ROLL CALL: Council members present were John K. Pratt, President; Roy Wrightsman, Vice President; Jack B. Butler; Cameron Martin; Rick Patton; Thomas Rohr and Susan Kramer, Auditor. Also present were Jason Frazier, Jessica Lancaster, Jim Meece, Stacie Amerman, John Martin, Matt Helderman, Bill McMichael, Judge Sam Swaim and Chester Crague.
- III. READING OF THE MINUTES: Minutes from November 14th, 2024 meeting were presented for approval. A motion was made by Roy Wrightsman and seconded by Cameron Martin to approve the minutes as presented and the motion carried unanimously.
- IV. ADDITIONAL APPROPRIATION REQUESTS: Additional Appropriations were denied until the December 30th, 2024 Council meeting.
