# COUNTY COUNCIL February 8th, 2024

- I. CALL TO ORDER: The Parke County Council convened in a regular meeting on Thursday, February 8th, 2024 to consider additional requests in excess of the budget allowed for 2024, and to conduct such other business as may be properly brought before the Council.

- III. READING OF THE MINUTES: Minutes from August 17<sup>th</sup> 2023 and January 11th, 2024 were presented for approval. A motion was made by Roy Wrightsman and seconded by Tom Rohr to approve the minutes as presented and the motion carried unanimously.
