

COUNTY COUNCIL
December 28th, 2023

- I. CALL TO ORDER:** The Parke County Council convened in a special meeting on Thursday, December 28th, 2023 to consider additional requests in excess of the Budget allowed for 2023, and to conduct such other business as may be properly brought before the Council.
- II. ROLL CALL:** Council members present were John K. Pratt, President; Roy Wrightsman, Vice President; Jack B. Butler; Rick Patton; Thomas Rohr; and Mary Anne Wood, Auditor. Also present were Dan Collom, Jim Meece, Jason Frazier, John Martin, Katie Potter, Jessica Lancaster, Kim Shorter and Mary Alice Gregg.
- III. READING OF THE MINUTES:** No minutes were presented to the Council for approval.
- IV. ADDITIONAL APPROPRIATION REQUESTS:** The Council considered additional appropriation requests as published in the newspaper December 13th, 2023.

Council President, John K. Pratt, reviewed the appropriations from written requests submitted by Auditor, Mary Anne Wood. Thus, the following ordinance was adopted: WHEREAS: it has been determined it is now necessary to appropriate more money than was appropriated in the annual budget for 2023, BE IT ORDAINED, by the County Council of Parke County, Indiana, for the expenses of said County government, the following additional sums of money are hereby appropriated and ordered set out of the funds herein specified, subject to the law governing the same: Jack B. Butler made a motion to approve the additional appropriation requests as advertised on December 13th, 2023. The motion was seconded by Tom Rohr and carried unanimously.

- Roy Wrightsman suggested that the Auditor be granted a blanket appropriation for any checks received from the Union Hospital regarding Security provided by the Parke County Sheriff's Department. Roy further explained that this is just a pass-thru process. Once these checks are received then the Sheriff's Deputies, who provided the security services, get paid. This is done every other week. Roy did not see the use in advertising in the paper for this appropriation when the Commissioners have made their decision that it is not pensionable. Roy Wrightsman made the motion to approve granting blanket appropriation authority to the Auditor for the year 2024 for Fund 4119 contingent on the appropriation cannot happen until a check is received from Union Hospital and

then pay can be made to the Sheriff's Deputies. The motion was seconded by Tom Rohr and unanimously carried.

V. TRANSFER OF FUNDS: The Council approved the request for the transfer of funds on a motion made by Roy Wrightsman. The motion was seconded by Rick Patton and carried unanimously.


XI. OLD BUSINESS: No old business was presented to the Council.


XII. GENERAL BUSINESS:

- Roy Wrightsman explained that the Payroll Clerk found that the payroll withholding tables for the County's share on fringe benefits and insurance have not been accurate or updated in some period of time. The County was not paying any share of the insurance for many employees. That has been corrected. There is a look back process being conducted as we speak today. There will need to be an adjustment made from insurance to self-insurance to cover the deficit in 2023.
