- Chris O'Brien, EMA Director:
 - O Stated he had nothing to report. Council asked if all money had come in. Chris stated yes, all money was in as of the 8th. All accounts are zeroed out.
- Katie Potter, Assessor:
 - o Finished assessment early. Started new construction. 290 permits.
 - Out of 82 appeals only 8 are going to be heard.
- Justin Cole, Sheriff's Dept:
 - o \$145,669 DOC inmates.
 - o Didn't have any outside inmates due to Covid.
 - o Zero cases of Covid currently at jail.
 - o Currently 54 inmates, 45 are our own.
- Jim Meece, Commissioner:
 - O East side Courthouse doors are done. Working on South side doors. Don with the help of Jeff Norman have been transporting doors back and forth to Delphi. Will not work on the North side doors until after Christmas.
 - Commissioners chose which roads would be done with Community Crossing funds: 100 E, 350 N, 720 S.
 - o Cemetery board convened and have appointed 3 new appointees.
 - O Insurance will be changed from UMR to Anthem.
- Julie Lanzone, EMS:
 - o Run volume twice as high as usual.
 - o 18 accounts have been turned over to collections.
 - o They have been having problems keeping staff.
 - O Stated there has been a lot of wear and tear on vehicles.
 - O Training program started November 8th, 2021 and is going well. Currently 8 students. Other agencies have contacted Julie about this training and there is interest in enrolling for the next class.
 - o 4 applicants have already been hired as drivers.
- Cyndi Todd, Redevelopment:
 - o Looking at child care across Parke County. Focus on early care and education.

X. NEW BUSINESS:

- 2022 Council meeting schedule to be approved at January 13th, 2022 meeting.
- Ordinance 2021-8: Salary Ordinance for 2022 Motion made by Jack B. Butler to approve, seconded by Larry Gambaiani. The Ordinance passed unanimously.

- Encumbrances are due to the Auditor by January 14th, 2022. Council will review February 10th, 2022.
- Discussion on comp time. Changes being made to pay out as overtime. Proposing to pay out of line 1000-15-01-1820-Additional Compensation. There should be enough left to pay liability out on January 17th, 2022 check which is first check of 2022 salary.
- Ronja Branson from Bloomingdale Home Telephone spoke about applying for grants. Applied for 43 locations which are mostly in Bloomingdale. Asking Council to match grant money. Council has spoken about using ARP money to match. Considering awarding money based on locations awarded in grants. Ronja expressed that BHT would be appreciative of whatever they may receive.
