

PARKE COUNTY ORDINANCE #2021-9

AN ORDINANCE adjusting the State prima facie speed limit.

WHEREAS, the Parke County Supervisor has conducted an engineering and traffic investigation as to the establishment and regulation of the speed limit for vehicles on County Road Mill Road starting at State Road 59 and ending 0.318 miles Northeast of State Road 59, said road section is 0.318 miles in Parke County, Indiana;

AND WHEREAS, on the basis of said investigation relative to special hazards and safety, it has been determined that the reasonable and safe maximum speed limit for vehicles on the above County Road, is less than the State prima facie speed limit as set forth in I.C. 9-21-5-2;

THEREFORE BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF PARKE COUNTY, INDIANA, PURSUANT TO I.C. 8-17-1-40 AND I.C. 9-21-5-6 THAT:

The reasonable and safe maximum speed limit for Parke County Road Mill Road from State Road 59 and ending 0.318 miles Northeast of State Road 59 has been decreased from the state prima facie speed limit, as properly authorized by state law, on the basis of an engineering and traffic investigation relative to special hazards and safety, to ten (10) miles per hour.


BE IT FURTHER ORDAINED, that any person violating the speed limit as described in this section shall be cited and prosecuted for a Class C Infraction.

BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect upon passage and approval by the Parke County Board of Commissioners and legal publication thereof.



MOTION TO ADOPT ORDINANCE ON SAME DAY AND AT SAME MEETING


