ORDINANCE No. 2022-

AN ORDINANCE PERMITTING VIRTUAL ATTENDANCE AT MEETINGS

WHEREAS, the Indiana law provides that powers not specifically reserved for the State are delegated to the local government and may be regulated by a municipality [Home Rule], as delineated in I.C. 36-1-3; and

WHEREAS, I.C. 5-14-1.5-3.5 was recently amended to permit the attendance by members of a governing body via electronic communication (virtually); and

WHEREAS, The County Council ("Council") for Parke County, Indiana finds it is in the best interests of the citizens of Parke County and the various members of the Council that serve those citizens to provide for virtual attendance at meetings under the particularized circumstances as set forth herein.

THEREFORE, IT IS ORDAINED that the virtual attendance at meetings of the Parke County Council is permitted, in compliance with Indiana Code, and under the following circumstances:

- 1. At least a quorum of the members of the County Council participate in the meeting in person.
- 2. The public is able to simultaneously attend and observe the meeting by electronic communication (virtually), unless it is held in executive session, as set forth in Indiana law.
- 3. The member(s) participating virtually in the meeting must be participating by video and audio conferencing.
- 4. A memorandum or minutes of the meeting must be prepared stating which members appeared in person, which members appeared virtually, and which members were absent, and what means of electronic communication were utilized. The memorandum/minutes must also include which members of the public attended and observed the meeting virtually.
- 5. All votes taken during a meeting in which a member or members appear virtually must be taken by roll call and such votes reflected in the minutes.
- 6. A member may not attend more than 50% of the Council meetings virtually unless they satisfy a requirement listed in I.C. 5-14-1.5-3.5(h).
- 7. A member may not attend a meeting virtually if the Council is taking final action to: adopt a budget; make a reduction in personnel; initiate a referendum; establish or increase a fee; establish or increase a penalty; use the County's eminent domain authority; or establish, raise or renew a tax (I.C. 5-14-1.5-3.5(j).
