Highway Department / Dale Kenney and Gina Mullen

Kenney is requesting to add Plaza Drive from ST66 to dead end to the Highway Department's Road Inventory. It is approximately 2,418 feet and runs between HNP Hotel and Ohio River Surgery Center in Rockport. *Gries motioned to add it to the inventory. Webb seconded the motion. Motion carried.*

Bridge #42 is located at 200N and Road 900W. This bridge has been upgraded to the critical list in need of repairs. This has been advertised and the bid opening will be at the April 1, 2025 meeting.

There was discussion about installing speed bumps in Saint Meinrad by the ballpark.

Spencer County has been awarded the full \$1.5 million in the Community Crossing Grant. They will need to fast track the paperwork and advertise for an opening at the second meeting in April. All money must be in place by May 1, 2025
