Bunner made a motion to approve \$1,000.00 for a refrigerator requested by the coroner. Guerich seconded the motion, motion approved.		

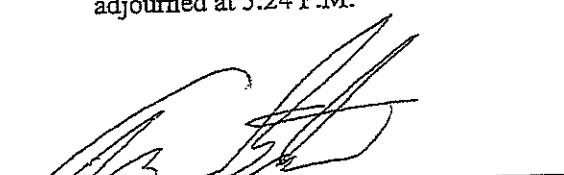
Health Department

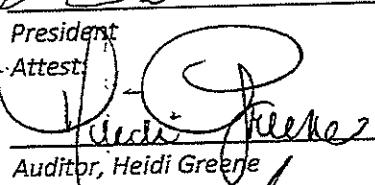
Broad Band

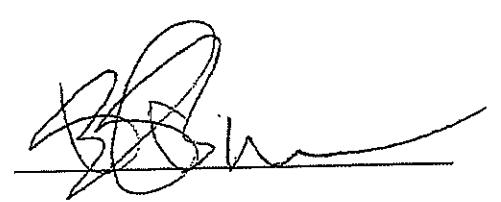
Ruxer made a motion to adjourn, Bunner seconded the motion, motion approved. Meeting was adjourned at 5:24 P.M.



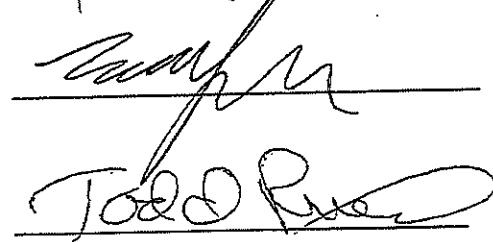

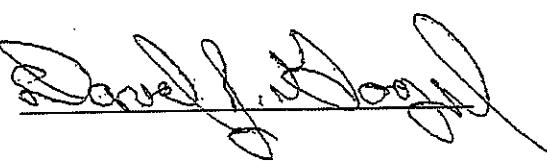
