The 2020 Innkeeper's tax that was collected decreased 30% compared to 2019

In 2020, the SCVB received \$26,033.68 in CARES funding to assist with wages and rent. They also applied for and received an employee tax credit of \$14,830.00.

Two (2) themed websites were used to promote SC. SantaClausInd.org and IndianaAbeLincoln.org.

In 2020, the combined page views for the websites reached 851,610.
