Meeting was called to order by President Jack Kroeger at 5:00 P.M.

Minutes

Binding Reviews from September 16th. Winsett made a motion to approve the minutes as presented. Knepper seconded the motion, motion was approved.

Non-Binding Reviews from September 16th needed a correction under Huff Township. It should have been 2.70 instead of 2.79. With that correction, Spaetti made a motion to approve the Non-Binding Reviews. Kress seconded the motion, motion was approved.

Regular Council minutes needed a few corrections. Kroeger wanted the Reassessment amount set out so it would be recognized as coming out of COIT and correct the spelling of Jon Dartt's name. With those corrections Bunner made a motion to approve the minutes from the September 16th meeting. Knepper seconded the motion, motion was approved.

Melton has discussed money that she can put toward the vehicle if the Council approves the purchase. They are also contemplating the sale of the Expedition, Bread truck and the Cert trailer, but have no idea how much money those vehicles might bring. Kroeger requested talking to the Auditor and coming up with a bottom number to be advertised from Cum Cap and we can take care of this at the next meeting.

Visitor's Bureau-Melissa Brockman

Brockman presented copies of the budget for the Tourism Commission; the Innkeepers Tax has been increased for 2015 from 4% to 5%. After discussing the budget the Council commended Brockman on a job well done. Kress made a motion to approve the budget. Knepper seconded the motion, motion was approved.

Old Business

Winsett said he wanted to thank the Auditor's Office for coming up with information for expenditures on rental properties. There was discussion on getting a grant to tear down the old jail and keeping all this information at the forefront.

Legal Report

Ayer explained that the Redevelopment Commission and the Commissioners have approved a Resolution and he had one prepared for the Council to sign. The Resolution is to approve expenditures from the AK Steel Settlement Fund in the amount of \$108,926.91 to Ice Miller, LLP and Lindsey Law Office in the amount of \$2,505.43. Spaetti made a motion to approve Resolution No. 2014-06 for these expenditures. Knepper seconded the motion, motion was approved.

Kress made a motion to adjourn. Winsett seconded the motion, motion was approved. Meeting was adjourned at 6:08 P.M.

The tax rate proposed is: 0.0308%

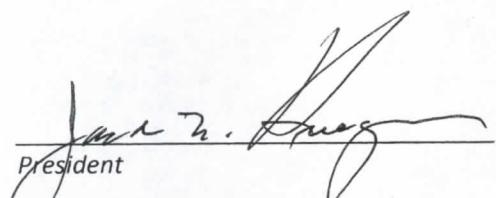
Knepper made a motion to accept the budget as presented. Bunner seconded the motion, motion was approved.

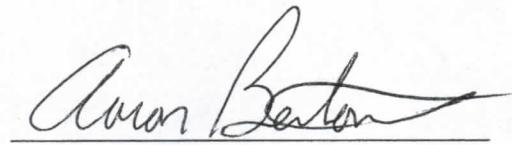

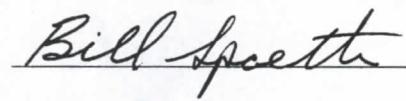

Winsett made a motion to approve the proposed budgets, levies, and tax rates for County, Reassessment, Highway, LR&S, Cum Bridge, Health, 4-H, and Cum Cap as presented. Spaetti seconded the motion, motion was approved.

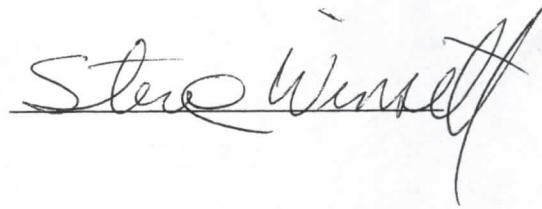

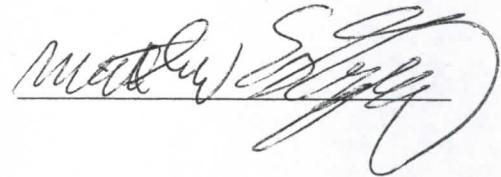












County Council Meeting

Since then we have corrected, resigned and submitted the correct figures to the State. The minutes are correct as far as what we did that night so what we need to do after we approve the minutes is make a motion to correct those figures.

Commissioner-Highway

Roof for Salt Building

Chuck Painter, Highway Superintendent explained that they had poured a concrete floor and put up walls on a 60 X 40 pad of concrete. Painter said he had approached the Commissioners at the last meeting about putting a roof over it and they told him it was too late to do an additional appropriation for this year, but maybe we could transfer money out of my Cum Bridge Budget and get the roof done. We are just running this by you to see what you think. Painter said the two estimates he received, he felt were a little high but for the Hoop Roof the estimate was \$65,000, and for the metal Roof the estimate was \$62,000.

Gogel explained there was money in Cum Bridge to take care of the roof; just wanted to see if the Council would agree to transfer the funds to get the job done.

The Council agreed to look at this again at the next meeting.

Old Business

Kroeger explained that the Cum Bridge Tax Rate for 2014 was .0184 which generated about \$260,000. We wanted to increase that and in order to increase the rate the Commissioners had to file a request with the State before July 1st. When they requested a new rate, they requested .10 the max rate, and the State granted that request. If we use that rate in Cum Bridge it would reduce the County General rate. When we get the 1782 Notice we can change the Cum Bridge Tax Rate. Commissioners and County Council both have to sign a letter asking for the reduction within 10 days of receiving the 1782 Notice. If we use .0285 for 2015 the levy generated would be \$421,043.00 that would enable us to move a million dollars to County General.

Benton made a motion to approve the letter to set the Cum Bridge Fund at .0285 and transfer the remaining balance to County General. Kress seconded the motion, motion was approved.

November 18, 2014

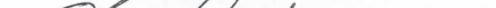
