New Business

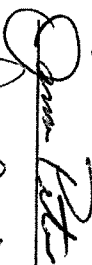

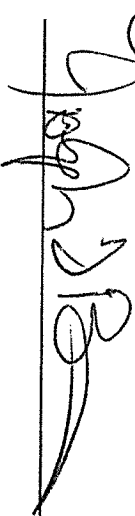
