- 1. All bids must be submitted on forms provided by Wabash County, Indiana. Bid information may be obtained from the Wabash County Highway Department, 800 Manchester Ave., Wabash or from the Wabash County Auditor located in the Wabash County Courthouse, 1 W. Hill St. Wabash, Indiana.
- 2. Bids must be submitted to the Auditor's office on or before 9:30 am on Monday, December 1st, 2025.
- 3. Bids will be opened at 9:30 am by the Board of Commissioners on Monday, December 1st, 2025, at the Wabash County Courthouse, Wabash, Indiana.
- 4. Bids will be opened as numbered. Each Bidder must place his bid in an envelope showing the item number on the outside of the envelope. Each item bid on must be in a separate envelope.
- 5. Two copies of each bid must be supplied.
- 6. Evaluation criteria will include the following: inspection, testing, quality, workmanship, delivery, and suitability for a particular purpose.
- 7. The County reserves the right to reject any and all bids if it determines such to be in the best interests of the County.

ITEM #1

One hundred twenty thousand (120,000) tons or less of crushed, washed maintenance stone. All materials must meet Indiana State Highway Specifications of 1999, Sec 904. Prices shown on bids must include loading of Wabash County Highway trucks at vendor's plant.

ITEM #2

Sixty thousand (60,000) tons or less of #53 gravel, and #9 gravel and #11 gravel. Prices shown on bids must include loading of Wabash County Highway trucks at vendor's plant.

ITEM #3

Five thousand (5,000) tons of #23 and #24 sand, and washed course ice control sand. All materials must meet 1999 Indiana State Highway Specifications, Sec 904 Sub. Sec (f). Prices shown on bid must include loading of Wabash County Highway trucks at vendor's plant. Bidders may show on their bids a delivered price for ton per mile.

ITEM #4

Seven hundred thousand (700,000) gallons or less of liquid asphalt including all grades of rapid curing and medium curing cutback asphalt and asphalt petroleum (Grade 1 -5). Material shall meet 1999 Indiana State Highway Specifications, Sec 902. Bidders shall submit unit prices on a per gallon basis F.O.B. Wabash County, and plant pick up. Bidders shall also show charge for unloading on the jobsite and for storage in vendor's tank at 800 Manchester Ave., Wabash, IN.

ITEM #5

Three thousand five hundred (3,500) tons or less of winter and summer cold mix. All bids for materials will be on a ton basis at bidders' plant. Materials must meet 1999 Indiana State Highway Specifications, Sec 403.

ITEM #6

- (A) Twenty-five thousand (25,000) tons or less of hot asphalt concrete base, binder, and surface materials furnished and applied with approved machine methods. Bidder shall provide automatic paver and rollers, each with necessary operator. Bidder shall provide all equipment, laborers, and foremen to lay roll and finish the hot asphalt mixture. County shall have the option of hauling the material to the job site. However, bids are requested for transportation of material. All materials to meet 1999 Indiana State Highway Specifications, Sec 902.
- (B) Bid will also be received for loading the above materials on Wabash County Highway trucks at vendor's plant.

High performance cold mix, QPR 2000, U.P.M.

Twenty thousand (20,000) gallons or less of liquid salt brine with a 23% salt solution. Bidder shall submit unit prices on a per gallon basis delivered to 800 Manchester Ave., Wabash, IN.

ITEM #9

Twenty thousand (20,000) gallons or less of liquid calcium chloride with Boost. Bidder shall submit unit prices on a per gallon basis delivered to 800 Manchester Ave., Wabash, IN.
