AN ORDINANCE VACATING PORTION OF PLATTED ALLEYWAY and STREETS

Be it ordained by the Board of Commissioners of Wabash County, Indiana, under authority of Indiana Code 8-20-1-1 et. seq., and all other acts amendatory thereof to the General Assembly of the State of Indiana;
