- 2. Welcome and opening remarks.** Chief Justice Loretta Rush welcomed the Board. She noted that she is still working with the legislature on the bill that will remove judicial officers; everyone needs to work together to address this issue. Chief Justice Rush also expressed gratitude for the good work that judicial officers are doing across the State and that she is proud to highlight their work at the State of the Judiciary.
- 3. Minutes.** A motion was made by Judge Bob Altice and seconded by Judge Clayton Graham to approve the minutes from the meeting held December 12, 2024. The motion carried unanimously.
- 4. Court of Appeals report.** Chief Judge Bob Altice welcomed the newest member of the Court of Appeals, Judge Stephen (Sam) Scheele. He noted that the Court of Appeals has already completed 18 traveling oral arguments this spring, have more scheduled, and that they are currently booking oral arguments for the fall.

- 5. Indiana Judges Association (IJA) report.** President, Senior Judge Heather Welch, reported that the legislature's sine die is on April 24th. She noted that the IJA lobbyists are still working on [SB 324](#), regarding violent arrestees, and [HB 1144](#), on the reallocation of judicial officers. Justice Goff noted that the Board of Directors is the governing body of the judicial branch and the Board should come up with a statewide solution to address the allocation of judicial resources.
- 6. Indiana Council of Juvenile and Family Court Judges (ICJFCJ) report.** President, Judge Kelsey Hanlon, also reported on the legislative session. ICJFCJ approached this session in a way that was conciliatory, trying to get the legislators to understand the work of judicial officers. [HB 1605](#) is a major CHINS bill, allows foster parent intervention, and limits the CHINS timeline, among many other things. They also worked on [HB 1626](#), a bill that requires written findings in contested custody matters.
- 7. Justice Reinvestment Advisory Counsel – Electronic Monitoring Report:** Staff attorney Michelle Goodman presented the electronic monitoring report to the Board as is required by statute. [SB 218](#) will alter the report, removing the false location reporting and changing the deadline to May 1st.
- 8. Court Alcohol & Drug Program Advisory Committee Rules:** Committee Chair, David Najjar, presented amendments to the Court Alcohol & Drug Program Rules and asked that the Board approve the changes. The changes are primarily related to the education requirements; the proposed rules also add instructions for closing a program and add requirements to inform clients about federal confidentiality. There weren't any public comments. He requested that the rules be implemented in 30 days. A motion to approve the rule changes was made by Judge Jon Brown, seconded by Judge Fran Gull, and approved unanimously.
- 9. Office of Judicial Administration (OJA) report.** Justin Forkner, Chief Administrative Officer, began by providing an update on the Commission on Indiana's Legal Future, which will continue until July 1, with some of the interim recommendations already being implemented. One of the recommendations is a public service scholarship which would have been funded if [HB 1049](#) passed. He also stated that the Supreme Court's big budget asks are for INjail, problem-solving courts, and court security.
- 10. Indiana Office of Court Service (IOCS) report.** Catheryne Pully, Executive Director, announced that the 2025 annual meeting is September 17-19 in Fort Wayne, and that the 2026 annual meeting is September 1-3 in French lick. She encouraged the Board to review their listing in the judicial directory and respond with any edits. Judges will receive an email about committee service on April 28.
- 11. Court Technology report.** Mary DePrez, Executive Director, updated the Board that Court Technology is still working on the next release of Odyssey. She encouraged judges to fill out

the survey about their use of the Judges' Edition of Odyssey; the use might change because Court Tech is building an e-filing application.

12. Legal regulatory pilot program: Bob Rath, Chief Innovation Officer, and Justice Derek Molter, presented the legal regulatory pilot program which came from the Legal Futures interim recommendations. The Innovation Committee is exploring the idea of a regulatory sandbox that would relax regulations and allow for allied legal professionals and non-profit law firms with sliding scale fees. Mr. Rath stated that the Indiana State Bar Association is working on a parallel project and that this is only a framework for evaluating pilot projects.

13. Other business: Chief Justice Rush noted that the bar passage rate for February was 47%, but the five students from Purdue Global and the one LLM that took the bar passed. She also tasked the Strategic Planning Committee with working on a plan to equitably distribute judicial resources across the state.

- 2. Welcome and opening remarks.** Chief Justice Loretta Rush welcomed the Board. She informed the Board that due to budgetary restraints, it is unlikely there will be a salary adjustment next year. She also shared that court security grants will be available this year.
- 3. Strategic Planning Committee:** Judge Jon Cleary and Judge Hunter Reece presented their idea to proactively deal with adding and subtracting courts, a new committee on judicial resources. This is prompted by this year's HEA 1144, which moved through the session without removing any courts until the last minutes. The proposal to create a committee was unanimously approved by the Strategic Planning Committee. The plan lays out membership to the committee, including a legislator at their request. This committee will be a unified group to look at possible changes with statute, rule, legislation, weighted case load study. Mark Spitzer, IJA president, noted that on July 1, 2025, IJA and Justin Forkner received a letter from Rep. Chris Jeter inviting the judiciary to prepare for upcoming legislative sessions. IJA will have a seat on the interim courts committee to be a part of that discussion, but they will be a non-voting member. There was a motion made to by Judge Jennifer Harrison to add a Marion County judge as a standing member and that it should be discussed by court versus by county. The proposed amendments were seconded by Judge Jon Brown. Judge

Michael Christofeno called for a vote, seconded by Judge Harrison. Three voted against the new committee proposal with no amendment. Volunteers for membership were encouraged to reach out to the Chief Justice.

4. **Minutes.** A motion was made by Judge Judi Calhoun and seconded by Judge Drew Bloch to approve the minutes from the meeting held April 15, 2025. The motion carried unanimously.
5. **Court of Appeals report.** Chief Judge Bob Altice made a short report that the Court of Appeals is doing well.
6. **Indiana Judges Association (IJA) report.** President, Judge Mark Spitzer, made a short report that all is well with IJA.
7. **Indiana Council of Juvenile and Family Court Judges (ICJFCJ) report.** President, Judge Drew Bloch, also reported everything is going well. He noted that he has a weekly meeting with Rep. Chris Jeter.
8. **Office of Judicial Administration (OJA) report.** Justin Forkner, Chief Administrative Officer, encouraged the Board members to attend the AI session tomorrow and review the proposal for AI use. He reminded the Board that judges are required to accept special judge appointments unless there is an ethical concern. He also announced that Terry Harrell is retiring September 24th. Court has appointed Ashley Hart as executive director of JLAP.
9. **Indiana Office of Court Service (IOCS) report.** Catheryne Pully, Executive Director, provided accomplishments from various divisions. She noted that there is a new GAL/CASA director, Melissa Cunyningham, and that the Guardianship Oversight Taskforce has a final report due to the court on December 1st. The judicial officer directory will be mailed end of September. District meetings will occur April and May 2026, next year and the Annual Conference will be Sept. 2-4 in French Lick. Justice Services is making process improvements for certification, has 142 certified problem-solving courts, and is making youth justice related expansion beyond the Juvenile Detention Alternatives Initiative (JDAI). There is a newly revamped Domestic Relations Benchbook on Incite. Supreme Court Services wrote 323 legal memos last years.
10. **Court Technology report.** Mary DePrez, Executive Director, provided a handout that lists all of the services that Court Tech provides and one about INjail, the new jail management system. E-filing will go live in December. She also noted that prosecutors have a system called secured public access and support for this is going away.
11. **Other business:** The Chief Justice closed by reminding the Board that district meetings will be in 2026. She also encouraged the Board to submit stories about good things that judicial officers are doing across the state.
