**RESPONDENT INDIANAPOLIS POWER & LIGHT COMPANY'S
WITHDRAWAL OF 30-DAY SUBMISSION AND REQUEST FOR SUBDOCKET**

Pursuant to the Commission's Order in this Cause issued February 16, 2018 ("February 16 Order") and 170 IAC 1-6-8(d), Respondent Indianapolis Power & Light Company ("IPL") hereby withdraws its 30-day submission made on March 26, 2018. As required by the February 16 Order, IPL hereby submits this request for a Phase I subdocket. In support of this Request, IPL states as follows:

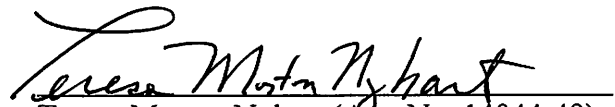
1. The February 16 Order requires all respondents to make a certain "30 Day Filing" on or before March 26, 2018. IPL formally submitted the required 30 Day Filing today, March 26, 2018, in accordance with 170 IAC 1-6-8 and the February 16 Order.
2. The February 16 Order provides that any respondent may withdraw its 30-day filing as authorized by 170 IAC 1-6-8(d). As stated above, IPL hereby withdraws its 30 Day Filing.

3. The February 16 Order provides that if a respondent withdraws its 30 Day Filing, the respondent shall file under this Cause a request for a subdocket. This filing is made to comply with this requirement.

4. If the Presiding Officers decide to establish an IPL Phase I subdocket, IPL will present its case-in-chief supporting its proposal for revising its rates and charges to reflect the new tax rate.

WHEREFORE, IPL withdraws its 30 Day Filing and respectfully requests an IPL Phase I subdocket as set forth above.
