Dear Ms. Becerra:

On March 26, 2018, Duke Energy Indiana, LLC ("Duke Energy Indiana" or "Company") submitted its Thirty-Day Filing pursuant to the February 16, 2018, Indiana Utility Regulatory Commission ("Commission") Order in Cause No. 45032 ("Order") (Phase 1) in compliance with the Commission's Order. The Company's Thirty-Day Filing contained its revised tariff sheets applicable to its rates and charges that would change as a result of using the new federal income tax rate instead of the federal income tax rate embedded in the current rate, as required under Phase 1 of the Order.

Also pursuant to Phase 1 of the Order and 170 IAC 1-6-8 (d) of the Commission's Thirty-Day Administrative Filing Procedures and Guidelines, the Company hereby provides notice that it is withdrawing its completed March 26, 2018, Thirty-Day Filing for Commission approval, and that it will be separately filing a request for a sub-docket under Cause No. 45032 to address the revision of Duke Energy Indiana's rates and charges to reflect the new federal tax rate.
