ALCOHOL AND TOBACCO COMMISSION

NOVEMBER 19, 2024

**CALL TO ORDER/NOTING OF QUORUM**

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, Deputy Director Serak, General Counsel Merritt, and Senior Attorney Beaucaire were in attendance.

**DISPOSITION OF MINUTES**

Vice Chairman Payne moved to approve the minutes from the November 6, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

**PROSECUTOR'S RECOMMENDATIONS**

PARTIES' AGREED DISPOSITIONS – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Fifty-six dispositions were submitted with fines totaling \$44,500.00. Commissioner Jones seconded. The motion was unanimously approved.

**HEARING JUDGE'S RECOMMENDATIONS**

**CONSIDERATION OF APPLICATIONS**

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Maginn moved to remand permit #RR49-41665 to the local board for reconsideration due to possible falsification of records. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine shipper applications. Vice Chairman Payne seconded. The motion was unanimously approved.

### **WAIVERS OF FEES – LETTERS OF EXTENSION**

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

### **ITEMS FOR DISCUSSION**

RR49-35771 EL FANDANGOS INC – Chair Allen noted this is a renewal application with the local board voting 3-0 to deny. An extension was granted at the November 6<sup>th</sup> meeting valid through today.

Commissioner Maginn stated this business was cited for numerous violations earlier this year that included minors loitering, no minimum food, public nuisance, and falsification of records, to name a few.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal and to deny any further extension. Commissioner Jones seconded. The motion was unanimously approved.

RR4941030 INDY BAR- & GRILL– Chair Allen noted this is a renewal with the local board voting 2-1 to approve for one-year.

Commissioner Maginn stated the business had a violation last year regarding an employee in possession of marijuana. There was also an issue with the patio not being on the floor plan but being used as part of the business. The owner was informed the patio must be on the floor plan if being used.

Commissioner Maginn moved to uphold the local board's recommendation to approve for one-year. Commissioner Jones seconded. The motion was unanimously approved.

DL5431636 STAR MARKET INC – Chair Allen noted this is a renewal with the local board voting 3-1 to approve.

Commissioner Maginn stated there was a violation for serving a minor last year.

Commissioner Maginn moved to uphold the local board's recommendation to approve the renewal of the permit. Commissioner Jones seconded. The motion was unanimously approved.

RR06-41756 SIXPENCE EVENTS LLC – Chair Allen noted this is a request for a catering hall designation.

Commissioner Maginn moved to approve the request. Vice Chairman Payne seconded. The motion was unanimously approved.

RR84-40209 NEW GOSHEN PUB INC – Chair Allen noted this is on for an extension request continued from November 6th.

Commissioner Maginn stated this was continued due to missing items, which is still an issue. The corporation has been dissolved and is not current with the Secretary of State.

Commissioner Maginn moved to approve the extension for 30-days and reset the matter for December 17<sup>th</sup>. Vice Chairman Payne seconded.

Chair Allen noted the permittee also needs to submit a letter relinquishing the permit at this location because a new permit application has been filed for this location and there cannot be two permits at the same location.

The motion was approved 4-0.

RR29-36708 K & L RESTAURANT LLC – Chair Allen noted this comes on for an extension request.

Commissioner Maginn stated this business filed their application under an LLC, but the Secretary of State paperwork is under a corporation. Also, it is expired with the Secretary of State. She would like to clear this up in the file. Also, a corrective action plan and certificate of insurance was submitted.

Commissioner Maginn moved to change the name to a corporation and to approve the remainder of the 90-day extension. Vice Chairman Payne seconded.

Vice Chairman Payne noted it seems like there are more issues with corporations and ownership lately. His concern and the Commission's concern is for the safety of the public and he questions whether the businesses are covered by insurance if the ownership of the businesses is at issue. The Vice Chairman feels the Commission may need to be stricter regarding this. He hopes those that are listening are paying attention.

Chair Allen stated the Commission has reached out to insurance companies regarding this issue, but she is not aware of any response.

Commissioner Jones noted he is hesitant to rename a corporation to name that does not exist, but he realizes this is only to correct our records.

The motion was approved 4-0.

DL49-30984 KARKIRPA 5 LLC - Chair Allen noted this has been resolved.

RR49-18714, RR02-34452, RR49-18929 P.F. CHANG'S CHINA BISTRO INC – Chair Allen noted these are on for extension requests.

Commissioner Jones stated these are requests for extension #6, #5, and #4. All of the requests are due to ownership issues. The lack of fixing this problem makes him think the permittee does not want to disclose the ownership.

Commissioner Jones moved to deny all three requests for extensions. No second was made on the motion.

Commissioner Maginn moved to approve 90-day extension for all three and noted the permittee will have to pay for the extensions. Chair Allen seconded because the permittee has been in contact with our attorneys to resolve the issue.

Vice Chairman Payne stated the permittee is only required to list all 2% shareholders. The time spent back and forth with our attorneys could have been spent finding and listing those shareholders. He feels they may be intentionally avoiding the law.

Commissioner Jones and Vice Chairman Payne voted no. Motion was approved.

RR49-32402 WILD EGGS OPERATIONS LLC – Chair Allen noted this has been resolved.

RR84-03694 WABASH VALLEY HOSPITALITY INC – Chair Allen noted this is on for an extension request.

Commissioner Jones stated this permittee just settled a violation and has an additional one pending. The pending violation is for public nuisance due to a shooting at the establishment. No security was present at the time. The police department has responded to approximately 26 calls to the business over the last two years.

Commissioner Jones moved to deny the request for extension. Commissioner Maginn seconded.

Chair Allen stated she reached out to the owner of record about submission of corrective action plans but has received no response.

Motion was unanimously approved.

DL54-31990 ASG OIL INC – Chair Allen noted this is on for an extension request.

Commissioner Jones moved to approve a fee-waived extension, due to scheduling errors on the part of the Commission. Commissioner Maginn seconded. The motion was unanimously approved.

RR46-28941 THE LEGACY CORPORATION – Chair Allen noted this is on for an extension request.

Commissioner Jones stated this is a second extension request. There are issues with ownership of this permit, however, a list of shareholders has been provided and is being checked by staff, which is why he is in favor of granting the extension.

Commissioner Jones moved to approve the request for a second extension. Commissioner Maginn seconded. The motion was unanimously approved.

DL45-04813 ECONOMY PACKAGE LIQUORS #3 – Chair Allen noted this is on for an extension request.

Commissioner Jones stated this is a third extension request. The local board was continued several times because of an unpaid violation that is now settled. There was also a missed local board hearing due to the death of a family member of the owner.

Commissioner Jones moved to approve the third extension request.

Commissioner Maginn asked for an amended motion limiting the extension to 30 days and noting strict compliance that this is the last chance to appear at the local board hearing.

Commissioner Jones accepted the amended motion for a 30-day extension and strict compliance with appearing at the local board hearing. Vice Chairman Payne seconded. The motion was unanimously approved.

RR02-30794 MATHEWS FORD LLC – Chair Allen noted this matter is on for an extension request. This permit was denied at the November 6, 2024 meeting after reconsideration of a conditional approval of the permit, because missing item was not submitted. The permittee has been in contact with the office and is making an effort to provide the proper certificate of insurance which is the missing item needed for issuance of the permit.

Chair Allen moved to approve a 30-day extension with instructions to continue to work on resolving the issues. Commissioner Maginn seconded. The motion was unanimously approved.

PRIOR CONDITIONAL APPROVALS FOR RECONSIDERATION – Chair Allen stated the list for this meeting should be considering the list from October 1, 2024 meeting and the holds that were not addressed at that time. However, the list has permits from the October 16, 2024 meeting. So, in order not to complicate things, or short permittees on time to clear the holds, Chair Allen moved to continue the list to the December 3, 2024 meeting. Vice Chairman Payne seconded. The motion was unanimously approved.

### **INACTIVE FILES**

Commissioner Maginn moved to make 17 permits dead that were posted on the November 6, 2024 meeting agenda. Commissioner Jones seconded. The motion was unanimously approved.

Chair Allen stated there are 10 permits being announced today to be made dead at the December 3, 2024 meeting.

## Noteworthy Violations for 11/19/24 Commission Meeting

TC14447001: AH Chase Petroleum (DBA: Chase Gas) in Gary, Lake County. In early 2024, the District 1 Excise office received information that Chase Gas was buying stolen tobacco products for resale. Officers Jason Szemes and Brett Painter led an investigation that involved reviewing video surveillance, interviewing the original theft suspect, and interviewing the store manager. It was determined the store was buying stolen cartons of cigarettes for resale. Violations were written for tobacco sales at a nuisance site and retail to retail sale of tobacco products. **The parties have agreed to a \$1,500 civil penalty and a 3-day suspension of the tobacco certificate.**

TC16469001: Smoker's World LLC (DBA: Smoker's World) in Fishers, Hamilton County. In early 2024, the District 3 Excise office received a complaint that Smoker's World was selling tanks of nitrous oxide for customers to inhale and get high. Sgt. Chaston Smithers conducted four separate buys of nitrous oxide at the location and then applied for and obtained a search warrant for the business. Officers located 54 canisters of nitrous oxide and 72 boxes of individual nitrous oxide charges that were in various flavors ranging from chocolate to tropical rainbow. Violations were written for tobacco sales at a nuisance site and nitrous oxide distribution. **The parties have agreed to a \$2,000 civil penalty and a 3-day suspension of the tobacco certificate.**
