ALCOHOL AND TOBACCO COMMISSION

OCTOBER 16, 2024

CALL TO ORDER/NOTING OF QUORUM

Chair Allen called the meeting to order and noted the quorum and the attendance. Vice Chairman Payne, Commissioner Maginn, Commissioner Jones, Prosecutor Wignall, Deputy Director Serak, General Counsel Merritt, and Senior Attorney Beaucaire were in attendance.

DISPOSITION OF MINUTES

Vice Chairman Payne moved to approve the minutes from the October 1, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved.

PROSECUTOR'S RECOMMENDATIONS

PARTIES' AGREED DISPOSITIONS – Vice Chairman Payne moved to approve the Parties' Agreed Dispositions, submitted by Prosecutor Wignall. Thirty-seven dispositions were submitted with fines totaling \$28,150.00. Commissioner Jones seconded. The motion was unanimously approved.

HEARING JUDGE'S RECOMMENDATIONS

No Hearing Judge's Recommendations

CONSIDERATION OF APPLICATIONS

Commissioner Jones moved to approve and incorporate by reference these lists of permits for renewal, which have been recommended by local boards and reviewed by said staff with the authority of the Commission, and hereby move for approval of same, pending any escrow hearings, and the inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve and incorporate by reference these lists of permit applications for a new permit or application for changes in location, ownership, or both of existing permits, which have been recommended by local boards and reviewed by at least two Commissioners and hereby move for approval of same, pending final floor plan approval by the Indiana State Excise Police and escrow, if needed, and inclusion of these lists as part of the minutes. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the catering applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the carrier applications. Vice Chairman Payne seconded. The motion was unanimously approved.

Commissioner Jones moved to approve the direct wine shipper applications. Vice Chairman Payne seconded. The motion was unanimously approved.

WAIVERS OF FEES – LETTERS OF EXTENSION

Vice Chairman Payne moved to approve the fee waived letters of extension issued the preceding weeks. Commissioner Jones seconded. The motion was unanimously approved.

ITEMS FOR DISCUSSION

RR03-38723 CULTURA ENTERTAINMENT LLC – Chair Allen noted this is a renewal with the local board voting 4-0 to deny for failure to appear.

Commissioner Maginn stated this was mistakenly scheduled for approval on the October 1, 2024 agenda, instead of being flagged for denial based on failure to appear at the local board hearing. So, therefore, the renewal was approved and issued.

Commissioner Maginn moved to reverse prior approval of the renewal and remand to the local board.

Chair Allen asked for an amended motion to include a letter of extension.

Commissioner Maginn amended the motion to include a fee-waived letter of extension. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-11398 TRI ENTERTAINMENT CORP – Chair Allen noted this is a renewal with the local board voting 4-0 to deny.

Commissioner Maginn stated this business has had a host of violations over the years. Recently there were six people shot at the establishment that resulted in one death. The business was being operated by a promoter at that time. The Commissioner stressed the problem with handing over operations to someone who has no interest in the business.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Commissioner Jones seconded. The motion was unanimously approved.

Vice Chairman Payne agreed with Commissioner Maginn regarding the use of promoters.

RR49-06959 H.A.T. ENTERPRISES, INC. – Chair Allen noted this is a renewal with the local board voting 4-0 to deny.

Commissioner Maginn stated this establishment has a history of violations and shootings.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Vice Chairman Payne seconded.

Commissioner Maginn made note in our rules there is a possible transfer process regarding denial of a renewal.

Commissioner Jones stated based on the great efforts by the current owners to change the business model and the building, after the appallingly poor management of the business in the past, he would be in favor of transferring the permit. The Commissioner believes a transfer has been filed.

Chair Allen stated given what was seen and presented, she would not be able to find the current owner demonstrated a high and fine reputation, which would be her concern for any renewal in this corporate name. A security guard blatantly stood by and watched felonies committed against an unconscious person. She stated our rules do give the Commission discretion regarding a transfer, but she can find nothing showing the local board was arbitrary or capricious in their recommendation to deny renewal.

The motion was unanimously approved.

RR49-31736 ANA'S HOUSE LLC – Chair Allen noted this is a renewal with the local board voting 4-0 to deny.

Commissioner Maginn stated the business has a history of violations and was warned at their last renewal about being compliant and not receiving more violations. They failed to comply.

Commissioner Maginn moved to uphold the local board's recommendation to deny the renewal. Vice Chairman Payne seconded. The motion was unanimously approved.

RR49-03006 DEER-BELL INC – Commissioner Maginn moved to continue this matter to the November 6, 2024 meeting. Commissioner Jones seconded. The motion was unanimously approved,

RR49-35771 EL FANDANGO INC. – Chair Allen noted this is on for an extension request.

Commissioner Maginn stated this would be a second extension. A corrective action plan has been submitted. There is a tax protest on file and, there is a problem with the Secretary of State's office that needs to be cleared.

Commissioner Maginn moved to approve an extension until November 6th, to allow time to clear up the pending issues. Commissioner Jones seconded.

Vice Chairman Payne commented that the corrective action plan needs to establish a method for making sure the bad behavior does not happen again, not just saying it will not continue.

Chair Allen agreed that the corrective action plans should state how employees now know proper procedures, not just that they know them. She also noted problems with the Secretary of State have been more frequent and companies need to make sure their Articles of Incorporation are current because if they expire, the corporation no longer exists.

Commissioner Maginn amended the motion to include enhancing the corrective action plan. The motion was unanimously approved.

RR49-33906 OVERSEAS PROPERTIES I, LLC – Chair Allen noted this comes on for an extension request.

Commissioner Maginn stated this permittee had violations last year that included one for hindering law enforcement, and a Form 1 Property Tax Clearance is still missing from the file.

Commissioner Maginn moved to approve a 90-day extension, after submission of the Form 1. Vice Chairman Payne seconded. Chair Allen voted to approve. Commissioner Jones voted, no, based on the violation for hindering law enforcement. The motion passed 3-1.

RR29-39867 ADRENALINE INDOOR ADVENTURE PARK LLC – Chair Allen noted this comes on for an extension request.

Commissioner Maginn stated permittee is missing a Form 1 and a Certificate of Insurance. Because there was a processing error on the Commission's part, the extension will be fee-waived

Commissioner Maginn moved to approve a second extension when the Commission receives the Form 1 and Certificate of Insurance. Commissioner Jones seconded. The motion was unanimously approved.

RR45-06264 BERNICE CARTER – Chair Allen noted this is on for an extension request.

Commissioner Maginn stated the Commission was recently notified that this permittee has been deceased for 10 years. The permit has continued to be renewed, so a violation was issued for falsification of records. The Commission received a court order awarding the permit to the owner's daughter. The Commissioner also noted a completed transfer, a Certificate of Insurance and a corrective action plan must be provided to the Commission.

Commissioner Maginn moved to continue this to November 6th to allow time for these items to be submitted. Commissioner Jones seconded.

Executive Secretary Serak stated the extension cannot be granted until the transfer is completed because the permittee is deceased and was the sole proprietor.

Chair Allen added our rules do allow for an expedited process for transferring after a court order following probate.

The motion was unanimously approved.

RR72-41490 5-7-10 LLC – Chair Allen noted Executive Secretary Serak has an update regarding this permit that was continued from the October 1st meeting.

Executive Secretary Serak stated after reviewing the access agreement between PC Pizza and 5-7-10 LLC ("bowling alley"), he determined it does not qualify PC Pizza to serve alcoholic beverages at the bowling alley location. Part of that qualification is waiving search and seizure rights, and an access agreement is not adequate to allow for that waiver. Also, a temporary restraining order has been issued, but caselaw shows it cannot bind the Commission's determination whether to issue or deny a permit, unless there is a property interest with the complaining party. The court has found that some property interest exists, not enough to issue a permit, but possibly enough for the court to find equitable remedies, which could include prohibiting the bowling alley from selling alcohol. And, the easement fails to include the most recent deed number, which is required for an easement to be enforceable and could go

against finding a property interest. Executive Secretary Serak recommended the Commission continue this indefinitely to allow for disposition of the litigation.

Commissioner Jones clarified that the comment regarding prohibiting the sale of alcohol if a property interest is found to exist, would only prohibit the bowling alley from selling, not PC Pizza.

Executive Secretary Serak also mentioned that the original floor plan submitted for PC Pizza erroneously included the bowling alley and has been corrected.

Chair Allen stated this matter will be continued until the litigation has reached an adequate conclusion for the Commission to make a determination regarding the permit.

INACTIVE FILES

Vice Chairman Payne moved to make 10 permits dead that were posted on the October 1, 2024 meeting agenda. Commissioner Maginn seconded. The motion was unanimously approved.

Chair Allen stated there are 6 permits being announced today to be made dead at the November 6, 2024 meeting. The Commission has worked extremely diligently to make sure permittees are notified of this date.



Noteworthy Violation for 10/16/24 Commission Meeting

RR8722515: Segovia Inc. (DBA: Jalisco Mexican Restaurant) in Newburgh, Warrick County. On July 20, 2024, District 5 Excise officers conducted an alcohol compliance check at the business. They were joined by an 18-year-old youth. That youth sat at the bar, ordered and was served a beer without being asked for his age, date-of-birth, or required to show any form of identification. This was the third violation for sale to a minor in the past five years. **The parties have agreed to a \$2,000 civil penalty and a 3-day suspension of the alcohol permit.**
