Old Buisness:

Website: The board reviewed the test website and are okay with how it turned out. It will go live after training.

Detour for StRd 36: Brittany is concerned the detour for St Rd 36 when they place the roundabout at St Rd 36 and Raider Rd will come down CR 525 W. Discussion was had about possibility of putting another speed limit sign on CR 525 W. Joe and Taylor said to put up a new sign we have to contact the State to get approval. Deb said she will call the State to ask where the Street signs are currently posted on their maps.

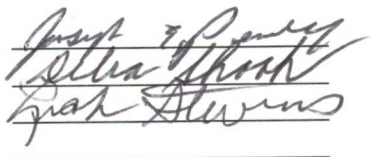
