College Dorm Placement Program

The college dorm placement program is a placement setting for youth 18 and older, who are in foster care.

Education and Training Voucher Program

The Education and Training Voucher (ETV) program is a federally funded-administered program designed to provide financial and academic support to youth who have aged out of the foster care system and who are enrolled in an accredited college, university, and vocational training programs. Students may receive up to \$5,000 per academic year based on their cost of attendance. Youth may receive assistance up to the day before their 26th birthday or 5 consecutive years; whichever comes first.

Opportunity Passport

The opportunity passport is a financial literacy program with a matching savings account.

OLDER YOUTH INITIATIVES

Older Youth Initiatives (OYI) is Indiana's program to help older foster youth transition to adulthood. OYI encompasses Older Youth Services (OYS), Transition to Successful Adulthood Services (TSA), Collaborative Care (CC) and Voluntary Services (VS). OYI programs and services assist current and former foster youth in the areas of housing, employment, education, physical and mental health, and financial education. OYI is designed as a continuum of care from ages 16 through 22.

Older Youth Services

OYS begins at age 16 and primarily focuses on developing independent living skills. OYS can be provided concurrently with other case plan goals such as reunification, guardianship, or adoption.

Transition to Successful Adulthood Services

TSA begins at age 17.5 for youths with case plans of Alternative Permanent Planned Living Arrangement (APPLA) who are expected to age out of foster care. It provides intensive independent living and transitional services to assist youth who are expected to age out of foster care.

Collaborative Care

CC begins at age 18 and provides extended foster care placement and supervision until age 21 while youths work on their successful-adulthood learning-plan goals.

Voluntary Services

VS provides after-care services to young adults ages 18 through 22 who aged out of foster care or whose cases closed because of guardianship or adoption at age 16 or older.
