III. Administrative Rule Update – Amanda DeRoss, FSSA Senior Attorney

Copayments Rule (LSA# 25-479) – Amends rules at 405 IAC-1 and 405 IAC-5 concerning co-payments for certain Medicaid Programs. This rule change is a result of House Act 1513 from 2023. A notice of the rule & public comment period was posted on 10.22.2025. There will be a public hearing on the rule on 11.24.2025.

Professional Dispensing Fee Rule (LSA# 25-436) – Proposed rule amends 405 IAC5-24-6 concerning the professional dispensing fee. Public hearing was hosted on 10.27.2025 & a second public comment period will be posted. This rule lowers the professional dispensing fee for fee-for-service prescriptions from \$10.48 to \$9.63.
