- Certified GAL/CASA volunteer programs in 85 of our 92 counties
- 2,674 active volunteers spent approximately 292,000 hours advocating for 20,605 CHINS and other children

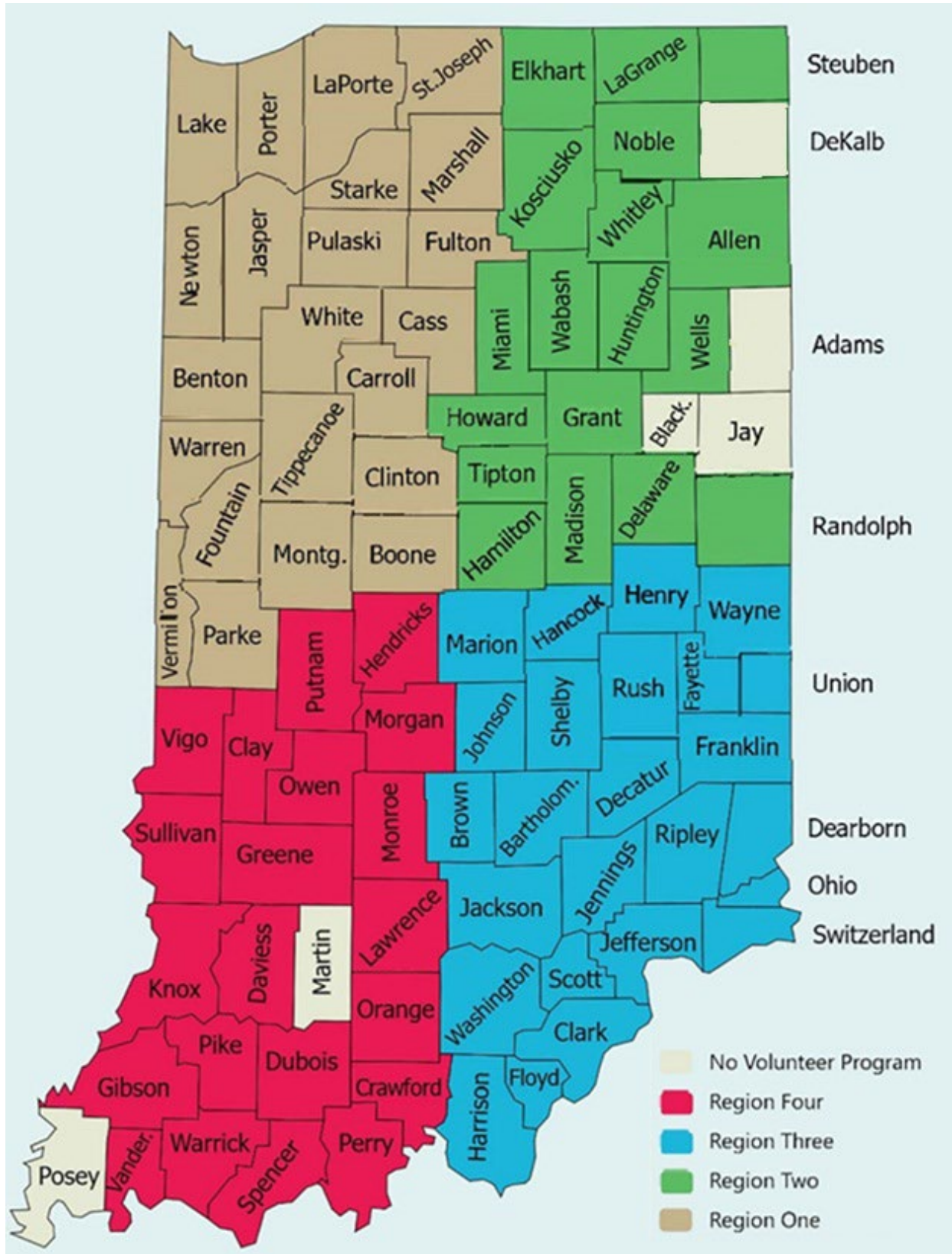
