INSPECTION OBSERVATIONS AND COMMENTS
<p>Upon arriving at 51687 CR 133, Bristol, Indiana 46507, it was apparent that the source was closed and, according to a Google and IN BIZ search, the source was closed and no longer in operation (photos 1, 2, and attached articles).</p> <p>Mark Line Industries, Inc. last Registration (36785) was issued on February 19, 2016, Administrative Amendment.</p> <p>IDEM OAQ has not received a revocation for Registration 36785. The last Annual Notification was submitted on January 13, 2017, for the 2016 compliance year. In searching Google, the source states that it is permanently closed. According to IN BIZ, Mark Line Industries, Inc., located at 51687 CR 133, Bristol, Indiana, was administratively dissolved on November 5, 2017. Registration 36785 will be revoked through IDEM Office of Air Quality (OAQ), as the source could not be reached and has been out of business for approximately five (5) years. According to the property record on June 30, 2017, Parcel No. 20-04-17-400-019.000-032, location address, 51687 CR 133, Bristol, Indiana 46507, this parcel was sold to Three Limes, LLC (see attachment).</p> <p>Barletta Boats is now located at this address. Barletta Boat Company has a Title V permit with IDEM OAQ (039-43547-00807).</p> <p>Registration 36785 will be revoked through IDEM OAQ, as the source could not be reached.</p>
