4. ED Evaluation – A. O’Haver reviewed the ED Evaluation with meeting attendees then asked for a motion to approve the ED Evaluation. Motion carried to approve the ED Evaluation by unanimous voice vote. M. Keyes asked for a motion to approve Performance Metrics and Goals. S. Executive Director's Report

Key Updates

- IDR is waiting on the remainder of its FFY 2023 funds to be disbursed from our federal funders following Congress passing the Omnibus spending bill in December.
- Operations Team rolled out a new travel training for staff based on the State's new travel system.
- Finance staff received training from the State Budget Agency on the State's new enterprise grants management project system. This is expected to improve the state approval process and management of IDR's federal grants.
- IDR will host 2 IDR interns, a Legal Intern and a Special Projects Intern, this summer through the Governor's Summer Internship program.
- Managers are completing annual performance reviews for all staff.

GOAL 1: IDR WILL COMPLY WITH ALL STATE AND FEDERAL REPORTING AND FINANCIAL PROCESSES.

- Please see the Fiscal Report for information on current grant balances and expenses.
- IDR completed all required federal and state quarterly and annual reports including annual SAM renewal, program performance reports, and financial reports. IDR meets regularly with all federal funding agencies.
- IDR staff, Commissioners, and MHAC members all timely completed the required state ethics training from the Office of the Inspector General (OIG). Because of IDR's previous advocacy, the training materials provided by OIG were accessible.

GOAL 2: IDR WILL LEVERAGE OPPORTUNITIES TO INCREASE ITS CAPACITY.

- IDR reviewed state and federal grant opportunities. There were no funding opportunities this quarter that fit within IDR's mission.
- IDR is working with the state to find additional opportunities to fund our Disability Law Fellowship. IDR is currently accepting applications for this program.
- IDR is again utilizing the summer intern program to support the work that IDR is doing. IDR will host one undergraduate and one law student intern this summer.
- IDR is working with the state to address the state's compensation study results to better understand the full impact to IDR's budget.



GOAL 3: IDR WILL ENSURE ITS POLICIES AND PROCESSES ARE EQUITABLE, TRANSPARENT, AND ACCESSIBLE.

- The MHAC and Commission state form applications were updated to change reference to “mental health.” Both standard and large print forms are available on the state form website as well as IDR’s website.
- IDR’s teams submitted individual team plans. These plans are used to identify case priorities, systemic initiatives, workgroups, education and outreach needs, and individual team processes. The plans were reviewed and approved by the Executive Director.
- IDR’s website redesign is ongoing. To increase transparency, IDR is including more information on the Commission, the MHAC and IDR policies, procedures, priorities and objectives, and outcomes.
- IDR staff reviewed all of the agency’s various internal document storage systems and gathered all current policy documents into a central place. Subject matter experts are working on revising various operational policies.
- The DCC Workgroup continues to review the revised policies with an eye towards promoting equity, transparency, and accessibility.
- IDR participated in the state agency pulse survey that looks at employee satisfaction and engagement. IDR ranked 3rd out of all state agencies with our staff reporting that they have what they need, flexibility to do their job.
- IDR is revising its all staff meeting to focus on issues applicable to all staff in promoting teamwork and inclusion.
- IDR’s Executive Director responded to 4 appeals in Q1. None of the appeals requested Commission review.

GOAL 4: EXECUTIVE DIRECTOR WILL SUPPORT IMPLEMENTATION OF THE COMMISSION’S STRATEGIC PLAN AND AGENCY PRIORITIES AND OBJECTIVES.

- ED met with members of the Commission to discuss performance expectations, tracking, and reporting. The ED will meet with that group quarterly.
- IDR’s ED supports the staff, Commission, and MHAC through direct supervision and technical assistance, connections to community resources, and approving requests for resources.
- Project-specific updates involving the ED are included in the Priorities and Objectives report.



Diversity, Equity, and Inclusion Report

GOAL 1: IDR WILL PROVIDE SERVICES TO MORE PEOPLE WITH DISABILITIES FROM BLACK, INDIGENOUS, AND COMMUNITIES OF COLOR.

- IDR joined the FISA Foundation Cultural Humility Learning Opportunity.
- IDR staff are reviewing current connections to help inform the development of a DEI focused outreach plan.

GOAL 2: IDR STAFF, THE IPAS COMMISSION, AND MHAC MEMBERSHIP WILL REFLECT THE BROAD DIVERSITY OF INDIANA.

- IDR is assisting the MHAC on developing a diversity plan for recruitment.
- IDR is working with the Governor's Office of Equity and Diversity to provide DEI related training opportunities for staff and Commission/MHAC members.
- IDR is currently seeking summer interns and applicants for the Disability Law Fellowship program.

GOAL 3: IDR WILL STRENGTHEN ITS RELATIONSHIPS WITH ADVOCATES AND ORGANIZATIONS LED BY PEOPLE WITH DISABILITIES, PEOPLE FROM MARGINALIZED COMMUNITIES, AND PEOPLE WITH LIVED EXPERIENCES.

- IDR will utilize summer interns to assist with coordinating and organizing IDR's outreach efforts for better reporting and strategic outreach efforts.
- Outcomes from IDR's participation on various workgroups are discussed in the Priorities and Objectives report. A full list of workgroups is available in the appendix.

GOAL 1: PREVENTING, FINDING, AND STOPPING ABUSE, NEGLECT, AND EXPLOITATION OF PERSONS WITH DISABILITIES IN FACILITIES.

PRIORITIES TO ADDRESS:

1.1. Investigate facilities serving children with disabilities.

Educate

Know Your Rights (Presentations and Handbook)

- FFY 2022: 4 presentations; 196 youth attended
- FFY 2023: 1 presentation; 13 attendees; 1 follow-up conversation with resident
- The Know Your Rights handbook is completing the design process.
- A MOU has been signed with Child Advocates to continue the Know Your Rights presentations in FFY 2023.

Monitoring Project – PRTFs and PSFs

Outcomes:

- Complaints related to the care and treatment of youth in residential facilities were reported to DCS including staff abuse, inappropriate restraints, group punishment, and lack of adequate staff.
- Three facilities reduced census to less than 20 youth due to critical staffing shortages. One facility will be acquired by another; all but 2 of the youth in the closing facility had transition plans by the end of Q1.

Advocate

No current advocacy initiatives tied to this project.

Community Connections

- IDR's investigations coordinator has developed a collaborative relationship with staff from DCS. This has allowed IDR to more quickly report issues, and to become aware of potential systemic issues involving facilities. Through this relationship, IDR also helped connect DCS to other state agencies to improve interagency coordination.

Educate

Presentations

- Natasha Henry gave an overview of IDR's services to a total of 31 new staff members at the monthly ESH/EPCC New Staff Orientations.

 - **Outcome:** IDOH completed a complaint survey

- IDR staff are in the process of contacting administrators and people currently incarcerated in each adult and juvenile correctional facility in Indiana.

Systemic Litigation

Indiana Protection and Advocacy Services Commission et al v. Commissioner, Indiana Department of Correction (1:08-cv-01317-TWP-MJD; Southern District of Indiana)
IDR continues to monitor the settlement agreement.

Success Story – Goal 1:

Following allegations that had an informal, unwritten policy prohibiting patients from purchasing more than 4 personal items per month with their own money, IDR opened a case.

IDR confirmed the policy and MSH agreed that purchase restrictions will be done on an individual basis when clinically appropriate and justified and in such all such cases, the restriction and reason for it will be noted in the patient’s treatment plan.



GOAL 2: BREAKING DOWN BARRIERS TO ENSURE RIGHTS ARE RESPECTED AND SUPPORTS ARE AVAILABLE FOR PERSONS WITH DISABILITIES TO PARTICIPATE IN AN EQUITABLE AND INCLUSIVE SOCIETY.

PRIORITIES TO ADDRESS:

2.1. Advocate on behalf of individuals with disabilities in the areas of abuse and neglect, civil rights, discharge from institutions, education, employment, health care, justice, self-determination, and voting.

Educate

Presentations

- Bonnie Bomer discussed IDR services, voting rights and employment with 11 students at BOSMA.
- Bonnie Bomer participated in an ADA & Disability Employment Awareness Fireside Chat panel hosted by the GCPD for 66 attendees.
- Zaida Maldonado-Prather presented “Reasonable Accommodations in the Workplace” to 14 deaf individuals from the Indiana Chapter of Black Deaf Advocates.
- Shari Stites discussed transition planning during six presentations at the Bartholomew County Transition Fair to a total of 168 high school students.
- Bonnie Bomer and Zaida Maldonado-Prather presented “Reasonable Accommodations in the Workplace” to 20 attendees of the Arc of Indiana annual conference.

Social Media

During National Disability Employment Awareness Month (October), IDR published a four-post campaign on our social media channels, highlighting reasonable accommodations, the benefits of hiring people with disabilities, and self-advocacy resources.

Individual Representation Select Outcomes

Coral – Civil Rights

“Coral” is Deaf and found it challenging to communicate with the staff of her assisted living facility. She also was unable to participate in resident meetings and found it difficult to order food in the cafeteria. Because of IDR’s advocacy, the assisted living facility’s parent company developed and implemented an effective communication policy in all their locations, including Coral’s facility.

Dina – Civil Rights

IDR assisted “Dina” with two cases involving denial of service from a business due to her service animal. In both cases, IDR confirmed the businesses had an appropriate service animal policy in place and provided education on the rights of people using service animals.

Ellowyn – Civil Rights

“Ellowyn” is a three-year-old with food allergies who needed to bring her own food to a children’s play area, instead of purchasing from the business’ restaurant. After the business refused, Ellowyn’s parents contacted IDR. Through IDR’s advocacy, the business granted Ellowyn a reasonable accommodation to bring her own food and confirmed a reasonable accommodation policy for other who may need it.

Kristian – Civil Rights

Because of her service animal, “Kristian’s” assisted living provider threatened to evict her. IDR successfully advocated for Kristian and her service animal to remain in the facility.



Cameron – Education

“Cameron” was an eleven-year-old with hearing loss who had recently changed schools. His new school was not providing an American Sign Language (ASL) interpreter. Because of IDR’s advocacy, Cameron’s school hired an in-person ASL interpreter, contracted with a virtual ASL interpreting company as backup, and implemented an FM amplification system.

TJ – Education

“TJ” was a seventeen-year-old who was preparing for residential placement due to his school alleging they were unable to support his physical and behavioral support needs. IDR successfully advocated for TJ to receive extensive services so that his needs could be met within his community school setting, and he could remain at home.

Stella – Employment

“Stella” was a cashier with limited lifting capacity. When her employer found out about her lifting restrictions, she was placed in new role. IDR assisted Stella in successfully requesting accommodations to the cashier position and she was returned to her former role.

Systemic Litigation

Indiana Protection and Advocacy Services Commission v. Indiana Family and Social Services Administration et al (1:22-cv-00906-JRS-TAB; Southern District of Indiana)

Plaintiff’s motion for preliminary injunction was denied; plaintiff is appealing. IDR met with several stakeholders to discuss the issue and possible solutions.

Policy Advocacy

- IDR signed onto a letter to Congress drafted by the National Disability Rights Network, National Federation of the Blind, American Foundation for the Blind, and American Council of the Blind. The letter explains how the Websites and Software Applications Accessibility Act would reduce barriers that individuals who are blind experience when attempting to access digital materials.

Advocacy Project – Police Pursuit Policies

IDR connected with stakeholders, such as the MHAC, during Q1 to get perspectives on what is working well and gaps IDR may be able to assist with.

Advocacy Project – Twice Exceptional Students Project

Bryan Gogg began his fellowship project with the goal of improving the K-12 education experience of twice exceptional students – high ability students with disabilities. Goals include publishing a law review or journal article on best practices and administrative advocacy.



FAPE in Institutions

- IDR continues to monitor provision of FAPE in juvenile institutions.
- 1 case opened in Q1.

2.3. Advocate for access to Home and Community-Based Services (HCBS).

Educate

Monitor and Investigate

Monitoring Project – State HCBS Transition Plan and Settings Rule Implementation

IDR is preparing to support individuals who may need to search for a new provider beginning in March 2023 following heightened scrutiny of assisted living facilities regarding compliance with the federal HCBS Settings Rule.

Agency Availability Survey

- IDR initiated a survey of home health agencies on the Marion County picklist for Aged and Disabled Waiver participants
- Survey seeks to determine current capacity of agencies to serve a new client and potential restrictions for clients using a Hoyer lift for transfers
- Data from the survey will be included in a forthcoming report about the status of direct care services in Indiana

Advocate

Policy Advocacy

- IDR submitted comments to the U.S. Department of Health and Human Services regarding proposed changes to Medicaid's eligibility regulations. IDR supported multiple proposed changes that should make it easier for applicants with disabilities to complete the Medicaid eligibility process.
- IDR participated in stakeholder feedback for a CMS on-site visit to Indiana regarding HCBS settings rule. IDR submitted written feedback prior to the visit.



- IDR submitted 3 letters to FSSA in response to the heightened scrutiny reviews of three assisted living facilities that are presumed institutional in nature pursuant to the federal Home and Community-Based Services Settings Rule. The settings that IDR assessed and commented about are:
 - Lutheran Community Home
 - Fall Creek Retirement Village (sometimes called Rawlins House, the name of the nursing facility associated with the Village)
 - Golden Years Homestead
- IDR ED is meeting with representatives from FSSA to better understand the various divisions' processes for HCBS compliance.

2.4. Advocate for the expansion of knowledge and use of supported decision-making/less restrictive alternatives to guardianship.

Educate

Presentations

- Justin Schrock presented “Ensuring Care and Avoiding Guardianship When Capacity Is in Question” during the Indiana University McKinney School of Law Health Law Symposium to 200 attendees.
- Melissa Keyes presented “What to Know About Decision-Making Supports” to 162 behavioral specialists connected to Outward Bound Support Services.
 - **Outcome:** Two emails were sent in follow-up to refer clients with guardianship concerns to IDR’s services.

Technical Assistance

- Justin Schrock and Melissa Keyes consulted with the American Bar Association Commission on Law and Aging regarding a guidebook being developed by the Commission to assist attorneys in litigating guardianship challenges and terminations.
- Melissa Keyes consulted with researchers from the University of North Carolina to provide feedback on the development of national recommendations for educators about supporting self-determination for youth.

Monitor and Investigate

Monitoring Project – Court Filings

IDR continues to review court cases of guardianships filed since the implementation of Indiana’s SDM bill. A summary of findings will be used to support advocacy efforts.



Advocate

Individual Representation Select Outcome

Yuseffa – Self-Determination

Nearing her eighteenth birthday, “Yuseffa” contacted IDR to enter an SDM agreement, appointing her parents as her supporters. IDR assisted Yuseffa in preparing and executing the agreements in Spanish.

Simon – Self-Determination

After he was struck by a car, “Simon” sustained a TBI and his parents were appointed his legal guardians. Simon’s recovery and advancement since acquiring his TBI led him to IDR who assisted him in terminating his parents’ guardianship.

Christian – Self-Determination

“Christian’s” inactive guardian was preventing him from receiving the services he needed, so he and his case manager contacted IDR. Upon opening the case, IDR discovered that Christian’s guardianship had already been terminated due to the guardian failing to file accountings. IDR provided TA to Christian and his case manager to support them in advocating for his care team to understand Christian did not need a new guardian and his options moving forward; Christian appointed his primary DSP as his healthcare representative and is living successfully without a guardian.

Advocacy Projects

- CYVYC Transition-Aged Youth – IDR, in partnership with SAI continue to support Indiana’s Youth Ambassadors on the development of their projects.
- Advanced Directives for People with ID/DD – updated materials for clients based on feedback from Q4 SAI picnic event. Determined organizations to reach out to for future events.

Policy Advocacy

Legislative – Guardianship Modernization – Melissa Keyes continues to participate in discussions at the state and national level on ways to improve Indiana’s guardianship code. Because of IDR’s involvement, a bill to access medical records prior to appointment of a guardian now expressly allows a person under guardianship to equally access their records.

2.5. Advocate to ensure elections are accessible to voters with disabilities.

Educate

Presentations

- Leah Grandy, with two Self Advocates of Indiana, presented the “Voter Empowerment” to 40 students at the Indiana School of the Deaf (ISD).
- Sam Adams, alongside co-counsel from the Disability Rights Advocates, presented at the Indiana chapter of the National Federation of the Blind to 34 blind and low vision Hoosiers on voting options and voting rights litigation.



Digital Media – Hoosiers Vote

- Over 90% of Q1 website visits were to a voting-related webpage.
- Over 75% of visits were to IDR's [Vote Early](#) webpage.

Monitor and Investigate

Monitoring – Polling Place Accessibility Surveys

- 13 early voting locations surveys in 4 counties by 3 surveyors.
- 12 recommendations issued for accessibility improvement.

Systemic Litigation

American Council of the Blind of Indiana et al. v. Indiana Election Commission et al. (1:20-cv-03118-JMS-MJD; U.S. District Court, Southern District of Indiana)

The parties spent Q1 discussing settlement and hope to resolve the case during Q2.

Press

Kristin Dulaney was interviewed by [NPR about voting rights in long-term care facilities and for voter with Alzheimer's and dementia](#).

Success Story – Goal 2:

After “Kari” was suspended from her position at a local library for an outburst directly related to her disability, she contacted IDR for assistance. Kari and IDR attempted to request reasonable accommodations; however, her employer was uncooperative. IDR assisted Kari in filing a charge with the EEOC who determined there was probable cause of disability discrimination. With IDR representing her, Kari filed suit against the library and received a neutral letter of recommendation, attorney’s fees for IDR, and monetary damages.

IDR will continue to provide reasonable accommodations for people with disabilities unable to access public materials.

Communication Plan

- PSP Team met with teams to discuss outreach needs for 2023.
- Content calendars created in collaboration with agency teams to produce and promote new self-advocacy resources.

Website Redesign

- The PSP Team is working with the Indiana Office of Technology and fellow IDR staff to update IDR's website. Goals of this project include making sure that the public knows what IDR is doing and providing more resources to enable people with disabilities to advocate for themselves.

Kristin Dulaney was interviewed by [WISH-TV about disability voting rights](#) and advocated for the station to also interview a voter with a disability. She connected the reporter with Melody Cooper of SAI.

Success Story – Goal 3:

IDR's [Hoosiers Vote website](#) received record-breaking visits in Q1. Specifically, in FY 2022, IDR's website experienced a total of 52,247 sessions. In Q1 of FY 2023 alone, that number rose to 186,566 which is over a 250% increase. Because of IDR's diligence in maintaining Hoosiers Vote as a self-advocacy resource, more than 180,000 people had access to accurate, focused, plain language content about how to engage in the election process.

Prison Project Update

Presented to the MHAC: February 15, 2023
Presented to the IPAS Commission: February 17, 2023

Background

In 2016, nearly 2 in 5 (38%) state and federal prisoners identified as having at least one disability.¹ This statistic is, “about two and a half times,” higher than adults report, “in the U.S. general population (15%).”¹

Goal

Gather information from Indiana correctional facilities to determine how IDR can improve its services to incarcerated people with disabilities.

Approach

Jails

- Attempt to connect with an administrator from all 92 Indiana county jails to learn basic information (such as capacity and staffing) and disability supports.

Prisons

- Request and review IDOC policies regarding disability.
- Attempt to connect with an administrator from all 42 adult and juvenile facilities to gather information about compliance with IDOC disability policies, provision of reasonable accommodations, access to assistive technology, etc.
- Attempt to virtually connect with at least 1 offender from at least 10 adult and juvenile detention facilities.

Initial Results

Jails

- 88/91 facility entries completed.
- 55% provided full information.

- 3/42 facilities closed (7%).

Offender Contacts

- Offenders from 14/42 facilities spoken to (33%).
 - Offenders from 14/29 facilities in which the administrative contact was successful (48%).
- Total of 44 offenders interviewed.

Next Steps

1. Review interview responses.
 2. Seek feedback from IDR Staff, MHAC, and IPAS Commission.
 3. Recommend systemic opportunities for IDR to improve conditions and services to offenders with disabilities in the correctional system.

Education

HB1543STUDENT BEHAVIOR (GOODRICH C) Establishes the behavioral health fund (fund) for the purpose of improving funding for individualized educational programs that have a behavioral intervention plan component for certain schools. Provides that the department of education, in coordination with the Indiana behavioral health commission, shall administer the fund. Creates an application and review process for the disbursement of a grant from the fund. Defines certain terms. Provides a procedure for a principal to place an aggressive student, who has been removed from a class, into the aggressive student's original class, another appropriate class or placement, or inschool suspension.
Current Status: 1/19/2023 - Referred to House Education

SB386 DIGNITY AND NONDISCRIMINATION IN EDUCATION (RAATZ J) Provides that a school corporation or qualified school shall not promote certain concepts as part of a course of instruction or in a curriculum or instructional program, or allow teachers or other employees to use supplemental learning materials to promote certain concepts regarding age, sex, gender identity, sexual orientation, race, creed, color, marital status, familial status, mental or physical disability, religion, or national origin. Requires a request to meet with a teacher for certain complaints. Requires each school corporation or qualified school to establish grievance procedures for certain complaints. Provides that, if a parent of a student or a student, if the student is an adult or an emancipated minor, is not satisfied with a final decision, the parent or student may submit a request to the secretary of education (secretary) to review the complaint and decision. Provides that the secretary's decision is a final order and is appealable. Requires the department of education to create guidance materials and professional development materials for use by school corporations, qualified schools, and teachers.
Current Status: 1/19/2023 - Referred to Committee on Education and Career Development

Employment

HB1047SMALL BUSINESS DEVELOPMENT (SHACKLEFORD R) Makes an appropriation of available federal funds to the office of small business and entrepreneurship for purposes related to minority owned small businesses.
Current Status: 1/9/2023 - Referred to House Ways and Means

HB1253OVERTIME COMPENSATION (HATFIELD R) Provides that, after December 31, 2023, certain employees must be paid compensation for employment in certain circumstances at a rate not less than 1.5 times the regular rate at which the employee is employed and, under certain circumstances, not less than two times the regular rate at which the employee is employed.
Current Status: 1/11/2023 - Referred to House Employment, Labor and Pensions

HB1490EMPLOYMENT DISCRIMINATION CLAIMS IN STATE COURT (SMITH V) Expands the definition of "employer", for purposes of civil rights enforcement, to include any person employing one or more persons within the state. (Current law defines "employer" to include any person employing six or more persons within the state.) Permits a civil rights action to be tried by a jury. Removes the requirement that both parties must consent before a civil rights claim is heard as a civil cause of action.
Current Status: 1/17/2023 - Referred to House Judiciary

HB1559EMPLOYMENT OF INDIVIDUALS WITH A DISABILITY (GREENE R) Establishes a tax credit for an eligible taxpayer that employs certain individuals with a disability. Provides for calculation of the amount of the tax credit. Requires the taxpayer to submit information to the department of state revenue to claim the credit.

Current Status: 1/19/2023 - Referred to House Ways and Means

SB310 MEDICAID BUY-IN PROGRAM (YODER S) Removes consideration of income and countable resources in determining an individual's eligibility for participation in the Medicaid buy-in program (program). Requires the office of the secretary of family and social services (office of the secretary) to apply for a state plan amendment or waiver to implement this provision. Prohibits the office of the secretary from considering resources and whether the individual participated in a specified program in determining the individual's eligibility or continuous eligibility for the program. Allows a recipient's participation in an employment network recognized by the federal Social Security Administration to qualify as participating with an approved provider of employment services. Changes minimum and maximum premiums that a recipient must pay. Requires that the premium scale be promulgated by administrative rule. Allows the office of the secretary to annually review the premium amount that a recipient must pay in the program. (Current law requires annual review of the premium amount.) Specifies changes in circumstances that must result in an adjustment of the premium. Specifies that a recipient in the program is eligible for the same services as offered in the Medicaid program. States that an individual's participation in the program does not preclude the individual from participating in a Medicaid waiver program. Specifies that a recipient of the program may simultaneously participate in a Medicaid waiver program and requires the office of the secretary to individually determine eligibility for both programs based on the individual's medical need requirements.

Current Status: 2/2/2023 - added as coauthor Senator Ford Jon

Notes: Emily Munson and Amber O'Haver are still attempting to meet with Senator Walker, Chair of the Senate Committee on Family and Children's Services, to explain why granting the bill a hearing would be a positive next step for people with disabilities.

February 6 – Emily Munson and Amber O'Haver will meet with Senator Crane to discuss the bill.

January 26 – Emily Munson and Amber O'Haver met with Senator Rogers to discuss the many positive ways this bill will enhance the ability of people with disabilities to work.

Emily Munson assisted the Indiana Chapter of the Association of People Supporting Employment First (IN-APSE) in drafting this bill. She also drafted a one-page information sheet about the bill.

General Disability-Related

HB1533INDIVIDUAL TAX DEDUCTIONS AND CREDITS (CHERRY R) Increases the amount from \$1,000 to \$1,500 per dependent child for purposes of the unreimbursed education expenditure tax deduction. Repeals the provision providing a tax credit for contributions to an ABLE account and replaces it with a provision with retroactive language that increases the credit to: (1) \$750 for an individual filing a single return; and (2) \$1,500 for a married couple filing a joint return. Provides a tax credit for contributions made to a public school foundation in an amount that may not exceed: (1) \$750 for an individual filing a single return; and (2) \$1,500 for a married couple filing a joint return. Provides that any combination of credits claimed under the ABLE account credit and the public school foundation credit may not exceed: (1) \$750 for an individual filing a single return; and (2) \$1,500 for a married couple filing a joint return.

Current Status: 1/19/2023 - Referred to House Ways and Means

SB141 AUTOMATED VEHICLES (TOMES J) Provides that a person may not operate an automated vehicle on a highway to transport passengers or goods unless a human safety operator is physically present in the automated vehicle to monitor the performance of the automated vehicle and to intervene if necessary. Provides that a registered automated vehicle must meet federal motor vehicle standards and regulations. Provides that a human safety operator shall meet all state and federal qualifications to operate a motor vehicle and an automated vehicle.

Current Status: 1/9/2023 - Referred to Committee on Homeland Security and Transportation

HB1354SERVICE ANIMALS (LEDBETTER C) Sets forth certain requirements when permitting or not permitting a person with a disability to bring a service animal on the premises of a public accommodation.

Current Status: 2/6/2023 - House Agriculture and Rural Development, (Bill Scheduled for Hearing)

Health Care

HB1201RARE DISEASE ADVISORY COUNCIL (BARTELS S) Establishes the rare disease advisory council (council) to address various issues concerning the needs of patients in Indiana with rare diseases and their caregivers and providers. Establishes duties and procedures of the council. Requires the Indiana department of health to provide administrative assistance to and pay the administrative expenses of the council. Establishes the rare disease fund to provide funding for: (1) publications; and (2) grants for studies and research; concerning rare diseases.

Current Status: 1/31/2023 - added as coauthor Representative Porter

HB1213COMMUNITY INTEGRATION AND HABILITATION WAIVER (OLTHOFF J) Establishes the special service review team to review denied applications for the community integration and habilitation waiver. Establishes reporting requirements. Provides that the review team expires December 31, 2024. Removes the emergency placement priority for individuals under a Medicaid waiver in which the primary caregiver is at least 80 years of age and alternate placement in a supervised group living setting is not available or is determined to be an inappropriate option. Removes the requirement in emergency placements that an alternate placement in a supervised group living setting is not available or is determined to be an inappropriate option. Adds emergency placement if the primary caregiver is at least 70 years of age or the primary caregiver has serious health concerns that would limit the primary caregiver's ability to care for the individual.

Current Status: 1/10/2023 - Referred to House Public Health

Notes: As of 1/24, bill does not include a review of administrative hearing decisions, nor agency review final orders. Review team is to be comprised of members selected by the director, and include someone from the Arc, a behavior consultant, someone from a case management company, and two other people chosen by the director; there is no legal participation, nor representation from self-advocates or family members. The reviews are to occur prospectively rather than consider past decisions.

HB1285IMPLICIT BIAS IN MEDICINE (SUMMERS V) Requires the medical education board to establish an education program for first year medical students that addresses implicit bias in the delivery of health care services to different racial and ethnic minority groups in Indiana.

Current Status: 1/11/2023 - Referred to House Public Health

HB1423RARE DISEASE ADVISORY COMMITTEE (PORTER G) Establishes the rare disease advisory committee.

Current Status: 1/17/2023 - Referred to House Public Health

Notes: As of 1/24, appears to include as many caregivers of people with rare diseases as folks with rare diseases. Strangely limits participation of folks with rare diseases to those between the ages of 18 and 30.

HB1432PERSONAL ALLOWANCE FOR FACILITY RESIDENTS (CARBAUGH M) Increases the personal allowance for residential care recipients and Medicaid recipients from \$52 to \$100.

Current Status: 1/23/2023 - added as coauthor Representative Pierce K

HB1458DOCTOR SCOPE OF TREATMENT AND DO NOT RESUSCITATE (BARRETT B) Provides that a declarant may include a person for whom a proxy has executed an out of hospital do not resuscitate (DNR) declaration if the person: (1) is at least 18 years of age and is certified as a qualified person; (2) is incapacitated or incompetent; and (3) has no representative who is able and available to execute an out of hospital DNR declaration. Defines "incapacitated" as related to an out of hospital DNR declaration. Defines "proxy" as related to an out of hospital DNR declaration and a physician order for scope of treatment (POST). Provides that a person's proxy may execute an out of hospital DNR declaration if certain conditions are met. Creates a declaration and order form to be used by hospitals if the declarant is incapacitated or incompetent. Allows a qualified person's proxy to complete a POST form if the person is incapable of making health care decisions and no representative is able and available to act. Allows a proxy to revoke a POST form or request alternative treatment. Provides that if alternative treatment is requested, the treating medical provider shall review the POST form with the declarant, the declarant's representative, or the proxy who has priority to act for the declarant. Makes conforming changes.

Current Status: 1/31/2023 - Referred to Senate

HB1459COOPERATIVE AGREEMENTS OF HOME HEALTH AGENCIES (BARRETT B) Adds language concerning statements and findings of the general assembly concerning home health agency cooperative agreements. Specifies that a home health agency may contract directly or indirectly through a network of home health agencies. Removes the expiration of the home health agency cooperative agreement statute.

Current Status: 1/17/2023 - Referred to House Public Health

Notes: Bill explicitly seeks to protect home health agencies from anti-trust protections.

HB1461LONG TERM SERVICES (BARRETT B) Requires the housing and community development authority to: (1) assess the feasibility of the development of new assisted living communities for low and middle income individuals; and (2) determine possible funding for the assisted living communities; and submit a report to the legislative services agency. Authorizes certain providers to perform functional eligibility assessments for individuals applying for the aged and disabled Medicaid waiver. Requires the office of the secretary of family and social services (office) to contract with more than one entity to provide functional eligibility determinations for individuals applying for the aged and disabled Medicaid waiver. Requires the office to submit an amendment to the Medicaid aged and disabled waiver to: (1) require that a functional eligibility determination be made not later than 72 hours after a functional eligibility assessment is performed; and (2) authorize certain providers to perform the functional eligibility assessments. Specifies reimbursement requirements when level of services is changed for a recipient of assisted living services. Specifies that integrated health care coordination and transportation are assisted living services. Prohibits the office from reducing the scope of services that may be provided by an assisted living services provider under the Medicaid aged and disabled waiver, as in effect on July 1, 2021. Specifies provisions that must be included in a risk based managed care program or capitated managed care program for specified Medicaid recipients. Removes the requirement that the transfer of comprehensive care beds in a health facility equalize the number of certified Medicaid beds in the county. Sets forth requirements for residential care facility administrators and notification requirements to the Indiana department of health upon a

vacancy or new hire of a residential care administrator. Requires the Indiana department of health to establish and administer the registration of a temporary health care service agency. Repeals current laws concerning the regulation of employment services. Provides that an individual who receives home and community based services under a Medicaid waiver and resides in a residential care facility has the same protections and rights afforded under landlord-tenant law concerning eviction. Specifies that the lease between the individual and residential care facility applies concerning transfer, discharge, and the eviction process. Prohibits the Indiana state board of health facility administrators from: (1) requiring a health facility administrator program for residential care facility administrators to require more than 40 hours of training; and (2) imposing any requirement that specifies the length of time that an individual has to complete a training program for a residential care facility administrator license. Removes references to a residential care facility administrator as a separate classification of license. Changes the requirements for the temporary permit for a health facility administrator from another state.

Current Status: 1/17/2023 - Referred to House Public Health

Notes: As of 1/24, promotes the establishment of new assisted living communities and would require that Medicaid reimburse assisted living facilities extra for providing transportation to residents. Also defines an HHA as 'healthcare personnel.'

HB1580 LICENSURE OF HOME HEALTH AIDES (O'BRIEN T) Provides for the licensure of home health aides by the Indiana department of health (state department). Establishes certain training and competency evaluation requirements for licensed home health aides. Provides that the state department shall include licensed home health aides in the registry of nurse aides. Makes a technical correction.

Current Status: 1/19/2023 - Referred to House Public Health

SB1 BEHAVIORAL HEALTH MATTERS (CRIDER M) Provides that, not later than December 31, 2024, the office of the secretary of family and social services shall apply to the United States Department of Health and Human Services: (1) for a Medicaid state plan amendment, a waiver, or an amendment to an existing waiver to require reimbursement for eligible certified community behavioral health clinic services; or (2) to participate in the expansion of a community mental health services demonstration program. Requires the division of mental health and addiction to establish and maintain a help line: (1) to provide confidential emotional support and referrals to certain resources to individuals who call the help line; and (2) that is accessible by calling a toll free telephone number. Reestablishes the Indiana behavioral health commission. Changes the name of the "9-8-8 crisis hotline center" to "9-8-8 crisis response center". Makes an appropriation. Makes conforming changes.

Current Status: 2/2/2023 - Senate Committee recommends passage, as amended Yeas: 13; Nays: 0

Notes: February 2 – Amendment #2, taken by consent in the Appropriations Committee, 'streamlined' Behavioral Health Commission membership by reducing it to eight participants. The single designated member required to have lived experience was eliminated.

January 25 – Tom Crishon submitted written comments to the Senate Appropriations Committee, describing the benefits 988 will bring to the disability community and suggesting that more individuals with lived experience be added to the Indiana Behavioral Health Commission.

SB4 PUBLIC HEALTH COMMISSION (CHARBONNEAU E) Defines "core public health services" for purposes of public health laws. Adds members to the executive board of the Indiana department of health (state department). Requires the state department to provide district or regional services to local health departments. Allows the state department to issue guidance to local health departments. Requires the state department to make annual local health department

reports available to the public. Changes the qualification requirements for a local health officer and requires certain training. Requires the state department to identify state level metrics and county level metrics and requires certain local health departments to report to the state department activities and metrics on the delivery of core public health services. Requires the state department to annually report on the metrics to the budget committee and publish information concerning the metrics on the Internet. Sets political affiliation limitations on local boards of health and adds two members to local boards of health. Requires a multiple county health department to maintain at least one physical office in each represented county. Provides that a new city health department cannot be created after December 31, 2022, but allows current city health departments to continue to operate. Creates the Indiana trauma care commission and sets forth the commission's duties. Specifies that certain vision screenings in schools for students may be performed by an ophthalmologist or an optometrist. Requires vision screening in kindergarten and first grade (current law allows for the screening in either grade). Modifies the list of vision tests that may be used. Requires the school to send to the parent of a student any recommendation for further testing by the vision screener. Allows for standing orders to be used for emergency stock medication in schools. Allows the state health commissioner or designee to issue a statewide standing order, prescription, or protocol for emergency stock medication for schools. Removes the distance requirement for an access practice dentist to provide communication with a dental hygienist.

Current Status: 2/2/2023 - added as coauthors Senators Garten, Glick, Breaux

Notes: February 1 – Emily Munson submitted written comments suggesting that individuals with lived disability experience should be added to the membership of the Public Health Commission, as well as local health boards. The comments explained the disparate impact people with disabilities experienced during the COVID-19 pandemic, partially due to the fact that the Indiana Department of Health failed to include anyone with lived disability experience on their workgroups and taskforces.

SB357 REGULATION OF HOSPITALS AND HEALTH FACILITIES (QADDOURA F) Sets forth requirements for the use of money and financial reporting for county hospitals concerning revenue generated from the ownership, operation, or management of a nursing facility. Prohibits the governing board of a county hospital or the board of a municipal corporation from including any incentives, bonuses, or salary increases for executives and employees based on metrics or performance measures concerning the maximizing of nursing facility revenues or profits.

Current Status: 1/12/2023 - Referred to Committee on Health and Provider Services

SB407 RARE DISEASE ADVISORY COUNCIL (DERNULC D) Defines "rare disease" as a disease that affects fewer than 200,000 people in the United States. Establishes a rare disease advisory council (council). Provides for appointment of the members of the council. Requires the council to fulfill certain duties for the benefit of patients with rare diseases. Requires the council to submit an annual report to the governor and the members of the senate health and provider services committee and the house public health committee.

Current Status: 1/19/2023 - Referred to Committee on Health and Provider Services

SB438 HOME HEALTH SERVICES (QADDOURA F) Sets forth minimum Medicaid reimbursement rates for home health services. Allows the office of the secretary of family and social services to reimburse parents and guardians of certain minor Medicaid recipients for the provision of home health services to the recipient. Establishes the home health services advisory council and sets forth the advisory council's duties.

Current Status: 1/26/2023 - added as second author Senator Alting

SB474 HOME HEALTH AGENCIES (BECKER V) Allows a home health agency to: (1) provide services in any county in Indiana; and (2) satisfy supervising home health aide services requirements by complying with federal law. Allows: (1) the Indiana department of health (state department) to

adopt rules concerning the oversight and supervision of the services a home health agency provides in noncontiguous counties; and (2) the state health commissioner to waive rules adopted concerning home health agencies if certain conditions are met. Provides that a home health agency is not required to conduct a preemployment physical on a job applicant before the individual has contact with a home health agency patient. Allows a registered home health aide to administer gastrointestinal and jejunostomy tube feedings to a specific patient if specified conditions are met. Requires the state department to approve at least one training curriculum concerning the administration of tube feedings. Repeals laws concerning drug testing of home health agency employees.

Current Status: 2/2/2023 - Committee Report amend do pass, adopted

Notes: February 1 – Emily Munson submitted written comments noting that nurse delegation to home health aides will ease some of the difficulty that people with disabilities who require skilled nursing care have in finding caregivers. However, the comments also suggested that completely eliminating drug testing requirements for home health aides will jeopardize the safety of some people with disabilities. IDR suggested that the bill be amended to require drug testing only when the home health agency has reasonable suspicion that a home health aide is under the influence of drugs or alcohol while working.

Justice

HB1006MENTAL HEALTH PROGRAMS (STEUERWALD G) Specifies the circumstances under which a person may be involuntarily committed to a facility for mental health services and specifies that these services are medically necessary. Establishes a local mental health referral program to provide mental health treatment for certain persons who have been arrested. Repeals obsolete provisions.

Current Status: 1/31/2023 - Senate sponsors: Senators Freeman, Crider, Koch

HB1194COMPETENCY TO STAND TRIAL (MCNAMARA W) Provides that certain licensed individuals may examine a defendant and testify as to whether the defendant can understand the criminal proceedings and assist in the preparation of the defendant's defense. Allows a court to dismiss criminal charges, without prejudice, upon motion by either party, if: (1) a substantial probability does not exist that a defendant will attain competency restoration or if the defendant has not attained competency restoration after six months of restoration services; (2) the defendant has a certain diagnosis; and (3) the defendant is charged with a misdemeanor or Level 6 felony. Makes conforming changes.

Current Status: 2/6/2023 - House Bills on Second Reading

HB1198SERIOUS COMMUNICABLE DISEASES (MCNAMARA W) Removes certain sentencing enhancements for battery and malicious mischief that relate to human immunodeficiency virus (HIV). Repeals certain offenses concerning the donation, sale, or transfer of blood or semen that contains HIV. Defines "responding safety officer" and makes battery by body waste a Level 5 felony if committed against a responding safety officer and certain other circumstances apply. Makes it a Level 6 felony for a person with a serious communicable disease who is not in compliance with a treatment plan to engage in a high risk activity with another person and not inform the other person of the disease.. Makes conforming amendments.

Current Status: 1/31/2023 - Senate sponsor: Senator Glick

Notes: January 12 – Melissa Keyes submitted written comments to the House Committee on Courts and the Criminal Code, describing the positive effects this bill would bring in reducing discrimination against people with HIV.

HB1440INVOLUNTARY COMMITMENT FOR ADDICTION TREATMENT (LEDBETTER C) Establishes a proceeding for the commitment of an individual who suffers from substance abuse. Provides that the petitioner must agree to pay the cost of the respondent's commitment. Establishes

requirements before the court may issue an order for commitment. Allows the court to order the respondent to receive treatment and to appear at an evaluation.

Current Status: 1/17/2023 - added as coauthors Representatives Bartels and Pack R

SB337 MENTAL HEALTH CARE (NIEZGODSKI D) Provides, for purposes of provisions of law under which a mentally ill individual may be committed if the individual is dangerous, that an individual may be "dangerous" even though the individual is not inclined toward violent behavior. Amends the provision of law under which an Indiana resident who has a mental illness may be voluntarily admitted to a facility to provide that, for purposes of that provision, "mental illness" includes psychiatric and neurobiological brain disorders, including bipolar disorder and major depressive disorder, that sometimes make an individual's performance of the normal activities of everyday life very difficult or impossible. Provides that the voluntary admission of an Indiana resident to a facility by the facility's superintendent may not be limited to Indiana residents who are referred to the facility by a court, the department of child services, a law enforcement agency, or any other officer or entity of state or local government. Provides that whether an individual has insurance coverage and whether the cost of the individual's care may be paid by or on behalf of the individual with private funds may not be considered in determining whether the individual: (1) is admitted to or allowed to continue receiving care in a state institution; or (2) is allowed to receive or continue receiving care from a community mental health center.

HB1071IMPLICIT BIAS CONTINUING EDUCATION (SHACKLEFORD R) Requires the medical licensing board of Indiana to adopt rules requiring a physician and a physician assistant who apply for a license or renewal to complete continuing education addressing the topic of implicit bias. Requires the Indiana state board of nursing to adopt rules requiring a nurse who applies for a license or renewal to complete continuing education addressing the topic of implicit bias. Establishes certain requirements for an implicit bias continuing education course. Provides that the Indiana professional licensing agency must maintain on the agency's website a schedule of or link to implicit bias continuing education courses that are available.
